**SUBJECT:** Amendment to the Memorandum of Understanding between Inland Empire Health Plan, Inland Empire Health Plan Health Access and Riverside County Regional Medical Center

**RECOMMENDED MOTION:** That the Board of Supervisors:

- 1) Ratify the Amendment between Inland Empire Health Plan (IEHP), IEHP Health Access and Riverside County Regional Medical Center effective June 1, 2011;
- 2) Authorize the Chairperson to sign four (4) copies of the Amendment;
- 3) Retain one (1) copy and return three (3) copies of the executed Amendments to Riverside County Regional Medical Center (RCRMC) for distribution.

**BACKGROUND:** On July 13, 2010, Agenda Item No. 3.70 a Memorandum of Understanding was approved with IEHP and IEHP Health Access to develop and implement a project for the management of Diabetes Care for members with diabetes. This Amendment extends the term of the project through December 1, 2012 and expands the project service area to include additional desert communities.

3 RATIFICATION AND APPROVAL OF THE FIRST AMENDMENT TO THE MEMORANDUM  
4 OF UNDERSTANDING WITH RIVERSIDE COUNTY REGIONAL MEDICAL CENTER FOR  
5 THE IEHP INNOVATION PROJECT FOR DIABETES CARE

6 WHEREAS, the Governing Board of Inland Empire Health Plan previously  
7 approved on Resolution 10-144, a Memorandum of Understanding with Riverside County  
8 Regional Medical Center for the implementation of an Innovation Project Pilot for Diabetes Care  
9 for the Inland Empire Health Plan (IEHP), and it is now necessary to amend the Agreement; and,

10 WHEREAS, the Chief Executive Officer of Inland Empire Health Plan, or his  
11 designee, have negotiated a First Amendment to the Memorandum of Understanding with  
12 Riverside County Regional Medical Center for these services; and,

13 WHEREAS, a copy of the First Amendment to the Memorandum of Understanding has  
14 been provided to each Board member, and the original shall be maintained by the Secretary to the  
15 Board; now, therefore,

16 BE IT RESOLVED, DETERMINED AND ORDERED by the Governing Board  
17 of Inland Empire Health Plan, at its regular meeting, assembled on July 11, 2011, that the First  
18 Amendment to the Memorandum of Understanding with Riverside County Regional Medical  
19 Center, for the Innovation Project for Diabetes Care, is approved.

20 BE IT FURTHER RESOLVED, DETERMINED AND ORDERED that the cost  
21 is not to exceed the Initial Project Funding in the amount of \$334,000 previously approved on  
22 Resolution 10-144.

23 BE IT FURTHER RESOLVED, DETERMINED AND ORDERED that the  
24 actions of the Chief Executive Officer in executing this First Amendment are ratified to June 1,  
25 2011.

26 BE IT FURTHER RESOLVED, DETERMINED AND ORDERED that the Chief  
27 Executive Officer, or his designee, is authorized to execute any necessary documents to  
28 effectuate this First Amendment to the Memorandum of Understanding, without requiring any  
further Board approval.

FIRST AMENDMENT  
TO THE MEMORANDUM OF UNDERSTANDING  
BETWEEN  
INLAND EMPIRE HEALTH PLAN AND IEHP HEALTH ACCESS  
AND  
RIVERSIDE COUNTY REGIONAL MEDICAL CENTER  
FOR INNOVATION PROJECT PILOT

WHEREAS, the Inland Empire Health Plan ("IEHP"), IEHP Health Access ("Health Access") (known collectively as the "IEHP Health Plan") and Riverside County Regional Medical Center ("RCRMC"), agree to amend the Memorandum of Understanding between them, dated June 14, 2010;

NOW THEREFORE, the parties agree as follows:

A. The language of ATTACHMENT C, PROJECT SERVICE AREA, is hereby deleted in its entirety and replaced as attached hereto (See amended ATTACHMENT C, PROJECT SERVICE AREA).

B. The language of Section 6.01 is hereby deleted in its entirety and replaced by the following language:

"6.01 This MOU shall be effective upon execution by both parties, and shall continue in effect until December 14, 2011.

An additional term of this MOU shall commence on December 15, 2011, and shall remain in effect until December 1, 2012, unless sooner terminated in accordance with the terms of this MOU herein."

C. Notwithstanding the date of execution, unless otherwise referenced, this First Amendment shall be effective June 1, 2011.

D. All other terms and conditions of said Memorandum of Understanding are to remain in full force and effect.

E. RCRMC certifies that the individual signing herein has authority to execute this Amendment on behalf of RCRMC, and may legally bind RCRMC to the terms and conditions of this Amendment, and any attachments hereto.


