BACKGROUND:

On October 6, 2009, the Board of Supervisors approved a pre-qualified list of architectural and engineering firms to be retained on an as-needed basis. The Economic Development Agency (EDA) has selected Shadpour Consulting (SC) Engineers, Inc., from the pre-qualified list to provide engineering services for the dedicated air conditioning for IT Rooms at Riverside Centre project.

The bid documents are now complete and EDA requests approval to solicit bids for construction of this project. EDA will return to the Board under separate cover to approve the project budget and execute any related project agreements.

The IT rooms require a dedicated air conditioning system that provides cooling 24 hours a day, year round to maintain services and protect network equipment. Currently the only air conditioning available is via shared use of the main building air conditioning. That system is limited to normal business hours usage and does not meet the needs of IT rooms.

The work associated with this project was budgeted for and funded as part of the acquisition of the Riverside Centre.
