BACKGROUND: (Continued)

The County entered into an agreement on October 19, 2010, with the effective date of July 1, 2010, with the Superior Court of California, County of Riverside to provide custodial services at designated Court facilities. Pursuant to the agreement, the parties may agree to extend the term up to three fiscal years. The Court requested that the Economic Development Agency (EDA) provide custodial services for the current fiscal year which began July 1, 2011 through June 30, 2012. The custodial services will be performed at the court locations listed on Attachment 5.

The agreed upon annual maximum is set not-to-exceed \$1,900,000 per year. There is no impact to county general fund and no request for matching funds.

1 **FIRST AMENDMENT TO AGREEMENT FOR CUSTODIAL SERVICES BETWEEN**
2 **THE COUNTY OF RIVERSIDE**
3 **AND THE**
4 **SUPERIOR COURT OF CALIFORNIA, COUNTY OF RIVERSIDE**

5 This First Amendment to the Agreement for Custodial Services is made and entered into by and
6 between the RIVERSIDE COUNTY ECONOMIC DEVELOPMENT AGENCY/FACILITIES
7 MANAGEMENT (“COUNTY”) and the SUPERIOR COURT OF CALIFORNIA, COUNTY OF
8 RIVERSIDE (“COURT”) (individually, “PARTY”, and collectively “PARTIES”) as follows:

9 WHEREAS, the Parties entered into that certain Agreement for Custodial Services (the
10 “AGREEMENT”) effective as of July 1, 2010; and

11 WHEREAS, pursuant to the Agreement, the Parties may agree to extend the Agreement for a
12 period not to exceed three fiscal (3) years; and

13 WHEREAS, the Parties desire to extend the term of the Agreement for an additional fiscal year;
14 and

15 WHEREAS, the Parties desire to amend the costs of services, as stated in Article 4.1, for fiscal
16 year 2011-2012; and

17 WHEREAS, all other terms and conditions of the Agreement would remain the same and in full
18 force and effect.

19 NOW, THEREFORE, the parties mutually agree as follows:

20 Section 1. Article 1.0, TERM AND EFFECTIVE DATE OF THE AGREEMENT is hereby
21 amended in its entirety to read as follows:

22 “This Agreement shall become effective on July 1, 2011, and shall remain in effect until June 30,
23 2012.”

24 Section 2. Article 4.1, COST OF SERVICES is hereby amended in its entirety to read as
25 follows:

26 “For fiscal year 2011-2012, the total cost of COUNTY services to the COURT under this
27 Agreement, shall not exceed one million, nine hundred thousand dollars, (\$1,900,000).”

28 Section 3. All other terms and conditions of the Agreement shall remain in full force and
effect.
