**SUBJECT:** Approval of the MultiPlan Participating Facility Agreement

**RECOMMENDED MOTION:** That the Board of Supervisors:

- 1) Approve the Participating Facility Agreement with MultiPlan effective October 1, 2011; and
- 2) Authorize the Chairperson to sign three (3) copies of the Participating Facility Agreement; and
- 3) Direct the Clerk of the Board to hold this Agreement as a confidential document, not subject to the release under the Public Records Act and Health and Safety Code 1457 (C) (1); and
- 4) Direct the Clerk of the Board to return all three (3) copies of the signed originals to RCRMC Administration. Upon final execution by MultiPlan, Inc., a fully executed agreement will be returned to the Clerk of the Board.

**BACKGROUND:** Multiplan, Inc. ("MPI") contracts with insurance companies and third party administrators that utilize the MPI network providers for health care services. MPI has requested
