**BACKGROUND:** Government Code § 25845, Riverside County Ordinance Nos. 457, 348 and 725 authorize the recovery of abatement costs in public nuisance cases, the recordation of a notice of abatement lien and inclusion of abatement costs on the tax roll as a special assessment upon approval of the Board of Supervisors.

Notices of Violation and Administrative Citations were issued. Subsequently, the property was brought into compliance. At the time the majority of costs were incurred, the property was owned by ASR Constuctors, Inc.. In 2010, the property was deeded to Another Meridian Company, LLC.

Research has indicated that these are related entities. One owner/member of ASR Constructors, Inc. (Alan Regotti) is an owner/member of Another Meridian Company, LLC. The address for service of process on both companies is the same.

The Notice of Hearing re Statement of Abatement Costs has been posted on the property and mailed to the property owner and all interested parties, as required by law. Copies of all relevant notices issued in this matter together with proof of service and posting have been separately filed with the Clerk of the Board and are made a part of the record herein, pursuant to Riverside County Ordinance 725.
