BACKGROUND: Government Code § 25845, Riverside County Ordinance Nos. 541, 348, 457 and 725 authorize the recovery of abatement costs in public nuisance cases, the recordation of a notice of abatement lien and inclusion of abatement costs on the tax roll as a special assessment upon approval of the Board of Supervisors.

Multiple Notices of Violation were issued. Additionally, on or about May 7, 2009, inspection warrant number MISC 2009-042 was executed. Subsequently, the property was brought into compliance.
