5. Approve the total project budget of \$744,700; and
6. Delegate project management authority for this project to the Assistant County Executive Officer/EDA in accordance to applicable Board policies.

**BACKGROUND:**

On July 27, 2010, the Board of Supervisors approved the plans and specifications, total project budget in the amount of \$1,435,608, and authorized the Clerk of the Board to advertise for bids for the Rubidoux Fleet Services Solar Shade Structure Energy Project. On August 12, 2010, 18 contractors attended a mandatory job walk. On August 31, 2010, the bids were opened and Petersen Dean was determined to be the lowest responsive bidder.

On September 9, 2010, Petersen Dean notified the Economic Development Agency (EDA) of their intention to withdraw their bid based on a clerical error. EDA and County Counsel have reviewed and accepted Petersen Dean's bid withdrawal. Of the remaining two bids, one was deemed non responsive by County Counsel and the other bid was over the estimated construction budget.

On November 30, 2010, the Board of Supervisors approved EDA's request to reject all bids and authorized the Clerk of the Board to re-advertise for bids using the same plans and specifications originally approved by the Board of Supervisors.

On January 12, 2011, bids from the second bid advertisement were opened and Bestek Engineering, Inc. was the apparent low bidder. However, due to Bestek Engineering, Inc's bid documents being incomplete, Bestek Engineering, Inc. was deemed non-responsive by County Counsel. S.H.E. Engineering & Construction Group were the second lowest bid, and were found to be in appropriate form by County Counsel.

On February 4, 2011, EDA received notification from County Counsel, that due to the two bid protests, and other issues with the bid documents, they recommend revising the bid documents and re-advertising for bid.

On September 14, 2011, bids from the third bid advertisement were opened and AAA Solar Electric, Inc. was determined the apparent low bidder. However, on September 15, 2011, EDA received a letter from AAA Solar Electric, Inc. formally requesting their bid proposal be withdrawn due to clerical calculation errors. County Counsel and EDA Project Management reviewed the documents from AAA Solar Electric, Inc. to withdraw their bid and determined they were within the 5 business day timeline and had provided sufficient information of their errors per the Public Contract Code. EDA asks that the Board of Supervisors relieve AAA Solar Electric, Inc. from their bid proposal, pursuant to Public Contract Code Section 5100 et seq., waive any minor irregularities in the bid from Solex Electronics, Inc. DBA Solex Energies and award to Solex Electronics, Inc. DBA Solex Energies.

**FINANCIAL IMPACT:**

All costs associated with this project will be fully funded through the Energy Efficiency Conservation Block Grant - American Recovery and Reinvestment Act, thus no net county costs will be incurred.

**AGREEMENT FORM**

THIS AGREEMENT, entered into this 24th day of October, 2011, by and between Solex Electronics, Inc. dba Solex Energies, hereinafter called the "Contractor", and the County of Riverside hereinafter called the "Owner".

**WITNESSETH:** That the parties hereto have mutually covenanted and agreed as follows:

**CONTRACT:** The Complete Contract includes all of the Contract Documents, to wit: The Notice Inviting Bids, the Instructions to Bidders, the Contractor's Proposal, Wage Schedule, Payment and Performance Bonds, the Plans and Specifications plus any Addenda thereto, the General Conditions, the Supplementary General Conditions, if applicable and this Agreement. All Contract Documents are intended to cooperate and be complimentary so that any work called for in one and not mentioned in the other, or vice versa, is to be executed the same as if mentioned in all Contract Documents.

**STATEMENT OF WORK:** The Contractor hereby agrees to furnish all tools, equipment, services, apparatus, facilities, transportation, labor and materials for the Rubidoux Fleet Services Solar Project. In strict accordance with the Plans and Specifications dated July 2010 prepared by MRC Engineering, Inc. herein after called the "Architect", including Addenda thereto as listed in the Contractor's Proposal, all of which are made a part hereof.

**TIME FOR COMPLETION:** The work shall be commenced on a date to be specified in a written order of the Architect and shall be completed within One Hundred Fifty (150) calendar days from and after said date. It is expressly agreed that except for extensions of time duly granted in the manner and for the reasons specified in the General Conditions, time shall be of the essence.

**COMPENSATION TO BE PAID TO CONTRACTOR:** The Owner agrees to pay and the Contractor agrees to accept in full consideration for the performance of the Contract, subject to additions and deductions as provided in the General Conditions, the sum of Five-Hundred Eighty Eight Thousand and No/100 dollars (\$ 588,000 ) being the total of the base bid plus the following addenda: 1, \_\_, \_\_. The sum is to be paid according to the schedule as provided in the General Conditions.

Pursuant to Labor Code, Section 1861, the Contractor gives the following certification: I am aware of the provisions of Section 3700 of the Labor Code which require every employer to be insured against liability for Worker's Compensation or to undertake self-insurance in accordance with the provisions of that code, and I will comply with such provisions before commencing the performance of the work of this Contract.
