BACKGROUND: This amended agreement between the Office on Aging (OOA) and the California Department on Aging (CDA) was approved by the Board of Supervisors on December 13, 2011 as agenda item 3.25. The agreement authorized funds for the OOA Medicare Improvements for Patients and Providers Act program (MIPPA).

Funds under this agreement assist in expanding Medicare beneficiary enrollment in the Prescription Drug Benefit Low Income Subsidy Program (LIS), the Medicare Savings Program (MSP), rural outreach activities aimed at preventing disease and promoting wellness.
