BACKGROUND: Government Code § 25845, Riverside County Ordinance Nos. 348, 541 and 725 authorize the recovery of abatement costs in public nuisance cases, the recordation of a notice of abatement lien and inclusion of abatement costs on the tax roll as a special assessment upon approval of the Board of Supervisors.

Notices of Violation and Administrative Citations were issued. On or about Sept. 14, 2010, the case was closed with the violation(s) remaining. Additionally, the property was annexed by the City of Desert Hot Springs (i.e., the property is no longer under County jurisdiction). Accordingly, the County of Riverside Code Enforcement Department seeks to recover its costs associated with the handling of this matter during the period of its jurisdiction.

The Notice of Hearing re Statement of Abatement Costs has been posted on the property and mailed to the property owner and all interested parties, as required by law. Copies of all relevant notices issued in this matter together with proof of service and posting have been separately filed with the Clerk of the Board and are made a part of the record herein, pursuant to Riverside County Ordinance 725.
