**BACKGROUND:** Community Improvement Designation funds will be given to support: Operation Safe House for much needed renovations to the Riverside Shelter and the Main Street Transitional Living Program, in support of March Air Field Museum's "2<sup>nd</sup> Annual Welcome Home Vietnam Vets" which recognizes local Vietnam Vets with a luncheon as well as aims to bring the Vietnam Travelling Wall for five days to this area for the first time since 1966, in support of Janet Goeske's "7<sup>th</sup> Annual Salute to Veterans Event" which directly benefits the Janet Goeske Foundation and Senior Center, in support of the Debbie Chisholm Foundation which provides wishes to catastrophically ill children, in support of Riverside AQuettes to improve equipment for the competitive synchronized swimming club and promote swimming opportunities in Riverside for youth and adults, in support of the Latina Women's Forum Program which provides a year-long leadership training for students at Ramona High School and invites 20 students from five high school in the City of Riverside to a leadership conference in Los Angeles, and in support of the Riverside Public Library Foundation which will work towards providing E-Books, a Job Search Center and Senior Spaces and Services.

I request that the Board of Supervisors approve a contribution of **\$20,500** to support these programs.
