**BACKGROUND:** Government Code § 25845, Riverside County Ordinance Nos. 348 and 725 authorize the recovery of abatement costs in public nuisance cases, the recordation of a notice of abatement lien and inclusion of abatement costs on the tax roll as a special assessment upon approval of the Board of Supervisors.

The first Notice of Violation for construction without permits was mailed and posted on or about August 16, 2007. On February 28, 2011, the case was closed (CV07-5429 – construction without permits). Regarding Case No. CV07-6017 related to an illegal business (trucking company), the case was opened in 2007 and closed by the County of Riverside Code Enforcement Department in February 2011 due to compliance.

The Notice of Hearing re Statement of Abatement Costs has been posted on the property and mailed to the property owner and all interested parties, as required by law. Copies of all relevant notices issued in this matter together with proof of service and posting have been separately filed with the Clerk of the Board and are made a part of the record herein, pursuant to Riverside County Ordinance 725.
