BACKGROUND:

Riverside County Board of Supervisors, the Economic Development Agency and Stater Bros. Supermarkets partnered to spearhead the fourth annual Riverside County Food Drive — Take A Bite Out Of Hunger. The food drive campaign ran from November 2011 through December 31, 2011, with a "jean sticker" campaign that 2011 Riverside County Food Drive ran through the months of December and January. A total of 4,694 pounds of food was collected in bins placed at various county offices. Food was distributed to needy residents by Food In Need of Distribution (F.I.N.D.) Food Bank and the Salvation Army. \$53,147.24 was raised, as listed in Exhibit "B" attached hereto, through the assistance of the Board of Supervisors, online donations and through the County fundraising campaign which allowed employees to buy "jeans-at-work" stickers.
