SPECIAL NON-CORE PRIVILEGES (SEE SPECIFIC CRITERIA)

If desired, non-core privileges are requested individually in addition to requesting the core. Each individual requesting non-core privileges must meet the specific threshold criteria governing the exercise of the privilege requested including training, required previous experience, and for maintenance of clinical competence.

MODERATE SEDATION

To be eligible for moderate sedation, the applicant must:

- Meet the qualification as required in the Privileging Criteria and Delineation for Moderate Sedation and the Patient Care Services Policy, 628: Moderate Sedation//Analgesia.
- View the Sedation Care training video or the online sedation training presentation.
- Take and pass a written moderate sedation exam (Video and test online site: www.rcrmc.org; click on Education Services, Moderate Sedation Site).
- Successful completion of one (1) proctored moderate sedation case under the direct supervision of a RCRMC practitioner holding this privilege.

Required Previous Experience: Knowledge of airway management and ACLS/PALS certification.

Maintenance of Privilege: Demonstrated current competence and evidence of the performance of at least four (4) moderate sedation cases in the past 24 months based on results of ongoing professional practice evaluation and outcomes.

CENTRAL LINE/PICC PLACEMENT

Criteria: Direct supervision and those technical and management skills which qualify the PA to perform central line/PICC placements and successful completion of proctoring of 2 procedures by a RCRMC physician holding this privilege.

Previous Experience: Demonstrated current competence and evidence of the performance of at least 2 procedures in the past 12 months.

Maintenance of Privilege: Demonstrated current competence and the performance of at least 4 procedures in the past 24 months based on results of ongoing professional practice evaluation and outcomes.

Requested

LUMBAR PUNCTURE

Criteria: Direct supervision and those technical and management skills which qualify the PA to perform a lumbar puncture and successful completion of proctoring of 2 procedures by a RCRMC physician holding this privilege.

Previous Experience: Demonstrated current competence and evidence of the performance of at least 2 procedures in the past 12 months.

Maintenance of Privilege: Demonstrated current competence and the performance of at least 4 procedures in the past 24 months based on results of ongoing professional practice evaluation and outcomes.

Requested
