BACKGROUND:

The intra-operative monitoring services are requested by Riverside County Regional Medical Center's (RCRMC) surgeons for the monitoring of patients while in surgery. These services include experienced and certified neurophysiologist and the equipment to perform intra-operative studies.

In fiscal year 09/10, County Purchasing, on behalf of RCRMC, released a Request for Proposal (RFP #MCARC123) to secure intra-operative monitoring services for the hospital. Based on the overall scores, Modern Diagnostic was determined to be the most responsive/responsible bid. On April 20, 2010, Agenda Item #3.62, the Board approved the Professional Services Agreement with Modern Diagnostic in the amount of \$139,000 to provide intra-operative monitoring services.

On March 15, 2011; Agenda Item #3.38, the Board approved an additional increase to the aggregate amount of \$240,000 as RCRMC's volume for OR services increased. RCRMC averages approximately \$22,000 each month for intra-operative monitoring services and anticipates the volume will continue to rise the following fiscal year.

The use of this service provides a safer surgical environment which in turn, would decrease poor surgical outcomes. Therefore, the Director of RCRMC requests the Boards approval of the recommended motions.

FINANCIAL IMPACT:

There will be no financial impact or change to the hourly rate set for this service. The increase to the aggregate amount of the contract is only due to an increase in volume of services. Funding for this service is 100% Hospital Enterprise funded and does not require additional County funds.

FOURTH AMENDMENT TO THE PROFESSIONAL SERVICES AGREEMENT

WITH

MODERN DIAGNOSTICS MEDICAL SERVICES, INC.
(Intraoperative Monitoring Services)

That certain Agreement between Riverside County Regional Medical Center ("COUNTY") and **Modern Diagnostics Medical Services, Inc.**, ("CONTRACTOR"), dated April 20, 2010; Agenda Item No. 3.62, first amendment dated June 24, 2010, second amendment dated March 15, 2011; Agenda Item No. 3.38, and third amendment dated April 5, 2011, is hereby amended effective January 1, 2012 as follows:

1. Amend the language of Section **4.0 Compensation, Paragraph 4.1**, to state the following:


"4.1 Maximum payments by COUNTY to CONTRACTOR shall not exceed the aggregate amount of two hundred sixty eight thousand dollars (\$268,000) through June 30, 2012. The COUNTY is not responsible for any fees or costs incurred above or beyond the contracted amount and shall have no obligation to purchase any specified amount of services or products. COUNTY shall not be responsible for payment of any of CONTRACTOR's expense related to this Agreement.

2. All other terms and conditions of this Agreement are to remain unchanged
