WHEREAS, the Seventeenth annual Spring Garden Tour will be held in Riverside on Saturday, May 5, 2012.

NOW, THEREFORE, the Board of Supervisors does hereby proclaim Saturday, May 5, 2012 as THE RIVERSIDE COUNTY REGIONAL MEDICAL CENTER FOUNDATION'S SPRING GARDEN TOUR DAY in recognition of the Foundation's efforts to promote and benefit the Child Abuse and Neglect Unit at Riverside County Regional Medical Center in providing services for the victims of injustices they serve in Riverside County and commend this observance to all citizens.
