THIRD AMENDMENT TO AGREEMENT BETWEEN THE CITY OF MORENO VALLEY AND THE COUNTY OF RIVERSIDE FOR VECTOR CONTROL SERVICES

This Amendment to Agreement is made by and between the City of Moreno Valley, California, a municipal corporation, hereinafter referred to as the "City", and the County of Riverside, through its Community Health Agency, Department of Environmental Health, hereinafter referred to as the "Contractor".

RECITALS:

Whereas, the City and Contractor entered into an Agreement entitled "AGREEMENT BETWEEN THE CITY OF MORENO VALLEY AND THE COUNTY OF RIVERSIDE FOR VECTOR CONTROL SERVICES," hereinafter referred to as "Agreement," effective July 1, 2008. (Attachment B)

Whereas the Contractor is providing professional and technical services as more specifically described in the Agreement.

SECTION 1 THIRD AMENDMENT TO ORIGINAL AGREEMENT:

- 1.1 "Exhibit B, Item C" to the Agreement (Fee Schedule) shall be amended at a rate not to exceed \$32,000 annually for services rendered. (Attachment A)
- 1.2 "Page 1, Item 3-A, TERMS OF AGREEMENT <u>Contract Term</u>" is hereby amended to extend the term of this Agreement for two additional years beginning July 1, 2012 with a termination date of June 30, 2014.
