BACKGROUND: (Continued)

Project Description: CDBG funds will be used by the Beaumont-Cherry Valley Recreation and Park District for construction of improvements to the Grange Community Center facility located in Cherry Valley. The Grange Community Center serves predominantly low-income areas of Cherry Valley and the City of Beaumont.

The Grange is utilized by residents for recreational classes, community meetings, a hot food and package meals program, and special events. Improvements will include removal of asbestos material in floors and ceilings; replacement of deteriorated ceilings, replacement of flooring, installation of energy efficient lighting, painting, and other improvements.
