BACKGROUND: The Transportation Improvement Program provides for the construction of drainage and street improvements on Brown Street in the Mead Valley area. The proposed drainage improvements will improve safety by conveying flows under Brown Street and reducing the need for road closures during rain events.

The low water crossing is located approximately 250 feet south of the intersection of Cajalco Road and Brown Street where Cajalco Creek flows east to west over the existing asphalt surface. This project will replace the existing Brown Street low water crossing by raising the profile of Brown Street to accommodate the installation of multiple barrel corrugated metal pipe culverts.

Additional road improvements include removing existing pavement on Brown Street between Souder Street and Cajalco Road, placing new asphalt concrete pavement including pavement reinforcement fabric, constructing reinforced concrete dip section, and other associated work.

Project funding is being provided through an agreement between the County and the Redevelopment Agency approved on June 28, 2011 under agenda items 3.119 and 4.18.

The submitted plans and specifications have been approved as to form by County Counsel.


