RECOMMENDED MOTION: That the Board of Supervisors approve and authorize the Chairman of the Board of Supervisors to execute the attached Option to Extend Agreement between the County of Riverside and Butler Amusements Inc.

BACKGROUND: On October 15, 2009, the Board approved a contract between the County of Riverside and Butler Amusements, Inc. to provide a carnival attraction at the Riverside County Fair and National Date Festival. The original contract was for the years 2010-2012 with two one-year options. Butler Amusements, Inc. is exercising their option for the last two years (2013 - 2014) of the contract and increasing the minimum financial guarantee from \$600,000 to \$700,000. County Counsel has reviewed and approved the attached documents as to form.

OPTION TO EXTEND AGREEMENT

In accordance with the Agreement between the County of Riverside and Butler Amusements, Inc. dated August 15, 2009, Section 6, this agreement may be extended beyond the initial three (3) year term by mutual written consent of the parties hereto. Riverside County Fair and National Date Festival in conjunction with Butler Amusements, Inc. hereby exercise the option to extend the terms of the Agreement for the 2013 & 2014 Riverside County Fair and National Date Festival. All terms of the original agreement shall remain the same for 2013 and 2014, with the exception that the financial guarantee in Section 10 for each of the option years shall be increased to \$700,000. By signing below both parties agree to mutual written consent.

BACKGROUND: On May 4, 2009, the Riverside County Fair & National Date Festival Fairgrounds released a Letter of Intent inviting all interested parties who meet the required qualifications to respond and compete in the RFP process. The deadline for all responses to the Letter of Intent was Tuesday, May 26, 2009. One response was submitted and received. The EDA reviewed the response by Butler Amusements and recommends the Board award Butler Amusements the contract due to their being the only response submitted meeting all required qualifications.

1 **AGREEMENT BETWEEN THE COUNTY OF RIVERSIDE AND**
2 **BUTLER AMUSEMENTS, INC. FOR**
3 **THE PROVISION OF A CARNIVAL ATTRACTION AT THE RIVERSIDE COUNTY**
4 **FAIR AND NATIONAL DATE FESTIVAL**

5
6 THIS AGREEMENT, dated as of 7 / 15 / 2009 (hereinafter referred to as
7 "AGREEMENT"), is entered into by and between the **COUNTY OF RIVERSIDE**
8 (hereinafter referred to as "COUNTY"), a public body, and **BUTLER AMUSEMENTS,**
9 **INC.**, (Hereinafter referred to as "CONTRACTOR").

10
11 WITNESSETH

12
13 **WHEREAS, COUNTY** owns certain real property (hereinafter referred to as
14 "FAIRGROUNDS") in the City of Indio for the purpose of providing a site for the
15 production of the annual Riverside County Fair and National Date Festival (hereinafter
16 referred to as "FAIR"); and

17 **WHEREAS, COUNTY** wishes to provide a carnival attraction (hereinafter referred
18 to as "CARNIVAL") at the FAIR; and

19 **WHEREAS, COUNTY** wishes to hire CONTRACTOR for the purposes and under
20 the conditions set forth herein; and

21 **NOW, THEREFORE,** in consideration of the mutual covenants and agreements
22 herein contained and for the good and valuable consideration, the receipt and
23 sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

24
25 **SECTION 1. Purpose.** The aforementioned parties for the purpose of providing a
26 CARNIVAL at the annual Riverside County Fair and National Date Festival hereby enter
27 into this contract. The number and kind of attractions and rides to be provided by
28 CONTRACTOR are described in more detail in Exhibit "A" Statement of Work to be
29 Performed, which is attached hereto and incorporated herein by this reference.
30

1 SECTION 2. Division of Fairs and Expositions. CONTRACTOR does hereby
2 represent that he or she, has been placed on the Early Qualification List by the State of
3 California Department of Food and Agriculture, Division of Fairs and Expositions per the
4 Division's current qualification criteria or has alternatively submitted all carnivals early
5 qualification documents to the COUNTY.
6

7 SECTION 3. Facility. The COUNTY hereby agrees to provide CONTRACTOR
8 space at the FAIRGROUNDS, subject to the terms hereof and subject to any conditions,
9 reservations, exceptions, and rights of way which are of record, for the purpose of
10 providing a carnival attraction during the annual FAIR. The CONTRACTOR spaces are
11 as follows:
12

13 a.) Adult Carnival Area -- The Adult Carnival Area is approximately 300,000 square
14 feet located in the center of the FAIRGROUNDS, proper, adjacent to Arabia Street.

15 b.) Kiddie Carnival Area -- The Kiddie Carnival Area is approximately 70,000
16 square feet in size located at the NW corner of the FAIRGROUNDS, or other mutually
17 agreeable location.

18 c.) Parking Area -- COUNTY shall inform CONTRACTOR of where trucks and
19 equipment not in use must be parked. Parking shall be in very close proximity to, or on
20 FAIRGROUNDS property.

21 d.) Concession Area -- The portions of the CARNIVAL area not occupied or used
22 for rides or shows may be used to operate food and game concessions subject to
23 terms, conditions and provisions contained herein and in accordance with which layout
24 will afford best utilization of space.
25

26 SECTION 4. Public Benefit. The COUNTY finds and determines that this
27 AGREEMENT and the use of the property is in the public interest and will not
28 substantially conflict with other uses of the property.
29

30 SECTION 5. Electric Service and Lighting. CONTRACTOR shall provide lighting
31 for the rides, shows, and concessions and surrounding area to the satisfaction of

1 COUNTY which may be neon, fluorescent, or incandescent lights on the rides, shows,
2 and concessions, and neon, fluorescent or incandescent light towers. All cables, cords,
3 electrical cords and hoses shall be bundled and ramped if in the public right of way and
4 compliant with all ADA regulations. CONTRACTOR shall provide generators for all
5 rides and or concessions.
6

7 SECTION 6. Term. The term is a three (3) year contract with two (2) one year
8 options. CONTRACTOR shall be required to provide all items listed in Part IV
9 "STATEMENT OF WORK TO BE PERFORMED" at least nine months prior to the next
10 scheduled FAIR date, for each year of the contact. Failure to do so may result in the
11 loss of any and all rights contained herein. CONTRACTOR shall have met all the terms,
12 or amended terms, of this AGREEMENT to the satisfaction of the COUNTY during the
13 previous year prior to any renewal of this AGREEMENT. This Agreement may be
14 extended beyond the initial three (3) year term by mutual written consent of the parties
15 hereto.
16

17 SECTION 7. Carnival Ride Tickets and Wristbands. COUNTY will provide all
18 CARNIVAL ride tickets and wristbands during the run of the FAIR. Said tickets and
19 wristbands shall be audited by COUNTY and the CONTRACTOR prior to the opening of
20 the FAIR and upon closing of the FAIR. A reconciliation of ride tickets and wristbands
21 sold will be made available for inspection by 10:00 a.m. the morning after the close of
22 the FAIR by CONTRACTOR. Financial settlement between CONTRACTOR and
23 COUNTY shall be completed on that date during each year of this AGREEMENT. 2010
24 Carnival Wristband prices are \$25.00 and \$20.00 pre-sale.
25

26 SECTION 8. Pre-sale Carnival Tickets. CONTRACTOR and COUNTY shall meet
27 annually at least one-hundred-eighty (180) days prior to the FAIR, if not sooner, and
28 agree on the pre-sale terms of CARNIVAL tickets. Pre-sale of carnival tickets shall end
29 on the first day of the FAIR at 10:00 a.m. COUNTY shall be responsible for all pre-sale
30 of CARNIVAL tickets and shall retain all pre-sale funds each year until financial
31 settlement occurs pursuant to Sections 7 and 10 herein. Any commissions associated

1 with pre-sale carnival tickets shall be borne by both CONTRACTOR and COUNTY
2 equally.

3
4 SECTION 9. Mandatory Riverside County Sheriff's Department Carnival
5 Security. CONTRACTOR shall provide Forty Five-Thousand Dollars (\$45,000) in
6 Sheriff's Department carnival security during the three (3) year term of this
7 AGREEMENT, in installments of Fifteen-Thousand Dollars (\$15,000) per year, or as
8 otherwise agreed to by both parties in writing.

9
10 SECTION 10. Compensation. CONTRACTOR agrees to pay COUNTY a
11 guarantee of Five Hundred Fifty Thousand Dollars (\$550,000) for 2010, a guarantee of
12 Five Hundred Seventy-Five Thousand Dollars (\$575,000) for 2011 and a guarantee of
13 Six Hundred Thousand Dollars (\$600,000) for 2012 for the rights and privileges granted
14 herein, or a guarantee percentage of the amounts in the manner set forth below,
15 whichever amount is ultimately greater:

- 16 a) Forty one percent (41%) of ride gross ticket sales during the FAIR and Forty
17 percent (40%) of gross advance ticket sales; and
18 b) One Thousand Two Hundred Dollars (\$1,200) for each food concession and
19 Four Hundred Fifty Dollars (\$450) for each additional non-food concession in place
20 during the FAIR.

21
22 SECTION 11. Deposit. CONTRACTOR shall pay COUNTY a deposit of Fifty
23 Thousand Dollars (\$50,000) on or before November 6th during each year of this
24 contract. Said deposit shall be credited against payments required pursuant to Section
25 10.

26
27 SECTION 12. FAIR Scholarship Program. CONTRACTOR shall provide
28 funding in the amount of Ten Thousand Dollars (\$10,000.00) annually for the Riverside
29 County Fair and National Date Festival Scholarship Program.

1 SECTION 13. Price List and Ride List. CONTRACTOR shall provide to
2 COUNTY, no later than forty (40) calendar days prior to the opening day of the FAIR in
3 each year of the operation of this contract, a list of rides and prices to be charged for
4 each ride. Said list and prices to be subject to approval by COUNTY. CONTRACTOR
5 shall provide a fully operational carnival including quality rides, games, shows, and
6 concessions. The following minimum number of rides are to be supplied:

- 7 a) Spectacular Rides 10
8 b) Major Rides 20
9 c) Kiddie Rides 21
10 d) A maximum of 55 games shall be supplied with a minimum of 40.
11 e) A maximum of 10 food concessions including cook shack.

12
13 SECTION 14. Specific Admission Price. All attractions operated by the
14 CONTRACTOR under the executed contract shall require a specific admission price
15 which can be translated to an appropriate number of tickets. Each ticket must have a
16 standard monetary value. The admission price for rides, games, and shows may not be
17 less than the value of one ticket.

18
19 SECTION 15. Safety Inspections. The schedule of fair-time CARNIVAL
20 operations shall include a CONTRACTOR performed mechanical and ride safety
21 inspection (documented in writing, stating what was inspected, when, by whom, and the
22 findings) when 30% and 70% of the total anticipated number of hours of operation have
23 elapsed. Said inspector must demonstrate his or her qualifications as such to the
24 satisfaction of COUNTY and CONTRACTOR. CONTRACTOR shall provide and pay for
25 said inspection.

26
27 SECTION 16. Down-Time of Attractions. The daily schedule for operation of all
28 proposed rides, games, and shows, shall ensure, barring major power outages or acts
29 of God, that no more than five percent (5%) of the total CARNIVAL operation is down,
30 or otherwise not in operation at any given time during the hours the FAIR is proposed to
31 be open to the public, with the following exception: This portion of this AGREEMENT

1 shall only apply to rides, games, shows, or other attractions which are in safe working
2 order. CONTRACTOR shall not, under any circumstances, operate any rides, games,
3 shows, or other attractions which are not in safe working order.

4
5 SECTION 17. Equipment, Ride, and Attraction Maintenance. Fair-time
6 maintenance procedures for CARNIVAL grounds, equipment, and attractions shall be
7 established to include routine CONTRACTOR inspection by supervising personnel with
8 such frequency to ensure no unsightly conditions (e.g., litter, trash accumulation,
9 marred surfaces of any kind on CONTRACTOR or COUNTY Property within the defined
10 CARNIVAL area) will exist without attempt to correct the problem within a reasonable
11 period of time. Reasonable time must be defined according to the severity of the
12 condition. CONTRACTOR will maintain clean, attractive, brightly lit rides.
13 CONTRACTOR will provide ride report maintenance records to COUNTY upon request.

14
15 SECTION 18. Monitoring and Inspection. The following monitoring and
16 inspection activities will be performed by COUNTY:

17 a.) Immediately prior to the initial opening of the FAIR each year, the COUNTY will
18 do a complete walk-through with the CONTRACTOR, or his or her authorized designee,
19 and the Riverside County Fire Marshall;

20 b.) During each FAIR day, COUNTY will do a complete walk-through with the
21 CONTRACTOR, or his or her authorized designee; and

22 c.) At the completion of CARNIVAL take-down each year COUNTY will do a
23 complete walk-through with the CONTRACTOR, or his or her authorized designee.

24 d.) These monitoring and inspection activities by COUNTY shall in no way release
25 CONTRACTOR from its own obligations under this Agreement.

26
27 SECTION 19. Carnival Set-up and Take-down. CARNIVAL must be set up and
28 ready for inspection by 6:00 p.m. one day before the first day of each annual Fair.
29 CONTRACTOR shall not operate amusement ride unless a current permit to operate
30 has been issued by the Division of Occupational Safety and Health. Amusement rides
31 inspected and covered by a valid permit to operate in the preceding year may continue

1 to operate until further inspected, providing the owner/operator of the ride has made
2 written application to the Division for an inspection at least ten days prior to its operation
3 indicating where such ride will be available for inspection and the application remains
4 unacted upon. All CARNIVAL equipment shall be removed from FAIRGROUNDS within
5 72 hours of closing of FAIR. CONTRACTOR shall provide security for all CARNIVAL
6 equipment during take-down period per the terms and conditions of this Agreement.

7
8 SECTION 20. Hours of Operation. Daily hours of CARNIVAL operation shall be
9 as follows: Monday through Thursday 10:00 a.m. until 11:00 p.m.; Friday, Saturday and
10 Sunday 10:00 a.m. until midnight.

11
12 SECTION 21. Failure to Perform. COUNTY has established terms to be imposed
13 on failure to perform during the contract performance period. Penalties for failure to
14 provide rides shall be as follows:

15 a.) One Thousand Dollars (\$1,000.00) per day, per each Spectacular ride;

16 b.) Seven Hundred and Fifty Dollars (\$750.00) per day, per each adult ride, major
17 and family ride; and,

18 c.) Five Hundred Dollars (\$500.00) per day, per each kiddie ride.

19 The aforementioned penalties will be assessed at the time of the performance failure
20 and payable not later than the last payment for the Fair-time during which the non-
21 performance occurred. Said penalties shall be in addition to all other compensation paid
22 to COUNTY by CONTRACTOR. Said penalties shall be included in the rides and
23 concessions gross sales when determining the payment method set forth in Section 10a
24 and 10b.

25
26 SECTION 22. Vacation of Premises. CONTRACTOR shall be sure that all rides,
27 games, and paraphernalia shall be removed from FAIRGROUNDS no later than 72
28 hours after the close of each annual FAIR. Failure to remove any and all articles shall
29 result in a fine of not less than \$250.00 per day and/or market storage price if articles or
30 equipment must be stored, unless other arrangements are made in writing prior to the
31 closing of the FAIR.

1
2 SECTION 23. Authorized Carnival Representative. CONTRACTOR must
3 maintain one or more representatives who are authorized to take immediate action upon
4 any request of COUNTY at all times when CONTRACTOR's property is on the
5 FAIRGROUNDS. This person(s) must be identified to COUNTY as the
6 CONTRACTOR's authorized representative(s).

7 a) CONTRACTOR will be responsible for employees having training as specified
8 by the Division of Industrial Safety, Department of Industrial Relations.

9 b) During all FAIR operating hours, experienced and adequate personnel must be
10 on duty.

11 c) The number of employees hired during Fair-time operations shall be sufficient to
12 ensure that no CARNIVAL ride, game, or show will be without a minimum of one
13 qualified attendant at all times during scheduled hours of operation.

14
15 SECTION 24. Concessions. CONTRACTOR shall:

16 a) Be required to meet any and all applicable Riverside County Health Department
17 standards for the transportation, handling, processing, storage, cooking, refrigeration,
18 and otherwise selling or providing food and drink to the public; and

19 b.) Maintain high quality control standards for food and drink concessions at all
20 times; and

21 c.) Not sell, distribute, or otherwise provide any alcoholic beverages, including
22 beer or wine, cigarettes and tobacco on or around the FAIRGROUNDS or on any
23 adjacent COUNTY-owned property, at any time during the term of this AGREEMENT.

24
25 d.) No food concession booth is allowed on any exterior edge of the carnival
26 grounds. All food concession booths must be located at a minimum distance of 50
27 linear feet from the exterior line. Carnival rides must be on the exterior and concession
28 booths must be on the interior.

29
30 SECTION 25. Limitations on Sales/Concessions. No novelty concessions will be
31 allowed, as well as no straight sales operations (i.e., computer portraits, jewelry, antique

1 photo booths, etc.), without the written permission of COUNTY. Any such novelty
2 concessions approved by COUNTY shall require additional compensation to the
3 COUNTY.

4
5 SECTION 26. Prohibitions. CONTRACTOR shall not:

- 6 a) Operate games of chance; nor
7 b) Sell cigarettes, tobacco, beer, wine, or other alcoholic beverages; nor
8 c) Offer cash prizes or re-purchase prizes awarded in any game; nor
9 d) Offer as prizes: live ducks, chicks, or other live animals (except goldfish); soft
10 drinks in other than plastic containers; knives, firearms, or any items which could be
11 used as a weapon; posters or merchandise featuring nudity or promoting the use of
12 drugs; nor
13 e) Use or employ "Capers," "Shills," and/or any person posing as patrons; nor
14 f) Employ or use anyone, under the age of eighteen (18) years of age, in the
15 operation of any rides; nor
16 g) Employ or use anyone, under the age of sixteen (16) years of age, in the
17 operation of any games or other CARNIVAL attractions.

18
19 SECTION 27. Other General Requirements. CONTRACTOR will ensure the
20 following:

- 21 a.) Employees who have regular public contact shall be attired in clean uniformed
22 clothing; and
23 b.) The assigned area for CARNIVAL operations shall be arranged to protect the
24 public from safety hazards, equipment and maintenance operations; CONTRACTOR is
25 responsible for barricading all equipment and maintenance areas.
26 c.) Procedures shall be established to ensure reasonable security of all rides,
27 games, concessions, and other CARNIVAL equipment when not in use so that no
28 attractive nuisance or negligent conditions exists.
29 d.) All staff provided by CONTRACTOR shall be uniformly dressed in clean, new
30 or near new show shirts with show's logo. No shirts with other fair's logo may be worn.
31 All shirts must be tucked in at the waist.

1 e.) All staff provided by CONTRACTOR will wear uniform slacks, trousers or dress
2 shorts. No cutoffs, rag bottoms or rips in materials will be allowed.

3 f.) All staff provided by CONTRACTOR will be required to have neatly trimmed
4 hair. Any facial hair must also conform with a trim look.

5 g.) There shall be no smoking or chewing of tobacco in view of the public by any
6 employee or volunteer of CONTRACTOR. All smoking must be done in designated
7 smoking areas away from patrons. There shall be a \$50.00 fine for each infraction.

8 h.) Cart permit fees (including mopeds and golf carts) will be charged at FAIR
9 rates; however, CONTRACTOR will be provided two (2) complimentary golf cart permits
10 for the duration of the FAIR. Only electric carts are allowed. Golf carts are considered
11 a safety hazard. **Golf carts are prohibited on the Fairgrounds during Fair hours of**
12 **operation 10:00 a.m. to 10:00 p.m.** Only licensed drivers may operate a golf cart on
13 the grounds. An insurance certificate must be on file showing coverage for all carts.
14 Any cart that does not have an operating parking brake or works without a key will be
15 declared unsafe and must be removed from the grounds. Golf carts are to be driven at
16 a reasonable speed and with extreme caution at all times. If COUNTY/FAIR observes a
17 cart being driven in an unsafe manner, the permit will be revoked and the cart will be
18 removed from the grounds for the duration of the FAIR. Do not park in doorways or in
19 front of any concession or exhibit. Bicycles, skateboards, scooters and/or skates are
20 not permitted on the Fairgrounds.

21
22 SECTION 28. Termination by COUNTY. COUNTY shall have the right to
23 terminate this AGREEMENT forthwith:

24 a) In the event a petition is filed for voluntary or involuntary bankruptcy for the
25 adjudication of CONTRACTOR as a debtor; or

26 b) In the event that CONTRACTOR makes a general assignment, or
27 CONTRACTOR's interest hereunder is assigned involuntarily, or by operation of law, for
28 the benefit of creditors; or

29 c) In the event CONTRACTOR fails or refuses to perform, keep or observe any of
30 CONTRACTOR's duties or obligations hereunder.

1 SECTION 29. Termination by CONTRACTOR. CONTRACTOR shall have the
2 right to terminate this AGREEMENT in the event COUNTY fails to perform, keep, or
3 observe any of its duties or obligations hereunder provided, however, that COUNTY
4 shall have fifteen (15) days in which to correct its breach or default after written notice
5 thereof has been served upon COUNTY.
6

7 SECTION 30. Taxes. COUNTY shall require and CONTRACTOR shall pay before
8 delinquency, any and all taxes, assessments, license fees, and other public charges
9 which may be levied, assessed, or imposed by any governmental entity whatever,
10 whether federal, state, local, or otherwise, upon any interest of CONTRACTOR, upon
11 CONTRACTOR's business and any income derived there from, or upon any property of
12 CONTRACTOR. COUNTY shall in no way be responsible for deduction or payment of
13 any taxes related to CONTRACTOR's operations.
14

15 SECTION 31. Assignment. CONTRACTOR cannot assign or otherwise transfer in
16 any manner, any of its rights, duties, or obligations hereunder to any person or entity
17 without the prior written consent of COUNTY.
18

19 SECTION 32. Right of Entry. The COUNTY reserves the right for any of its duly
20 authorized representatives to examine the CARNIVAL facilities and grounds at any
21 time.
22

23 SECTION 33. Signs. CONTRACTOR shall not erect, maintain, or display any
24 signs or other forms of advertising upon any COUNTY property without first obtaining
25 the written approval of COUNTY. CONTRACTOR is responsible for obtaining any and
26 all necessary permits and paying any and all applicable fees in order to obtain said
27 permits.
28

29 SECTION 34. Hold Harmless.

30 a) CONTRACTOR represents that it has inspected the FAIRGROUNDS, accepted
31 the condition thereof, and fully assumes any and all risks incidental to the use thereof.

1 COUNTY shall not be liable to CONTRACTOR, its officers, agents, employees, guests,
2 subcontractors, or independent contractors for any personal injuries or property damage
3 suffered by them which may result from hidden, latent or other dangerous conditions on
4 or upon FACILITY; provided however, that such dangerous conditions are not caused
5 by the sole negligence of COUNTY, its officers, agents or employees.

6 b) CONTRACTOR shall indemnify and hold harmless COUNTY, its Agencies,
7 Districts, Special Districts and Departments (including FAIR and CORAL), their
8 respective directors, officers, Board of Supervisors, elected and appointed officials,
9 employees, agents and representatives from any liability, claim, damage or action
10 whatsoever, based or asserted upon any act or omission of CONTRACTOR, its officers,
11 employees, subcontractors, agents or representatives arising out of or in any way
12 relating to this Agreement or relating to the use of the FAIRGROUNDS or the condition
13 thereof, including but not limited to property damage, bodily injury, or death
14 (CONTRACTOR's) employees or contractors included). CONTRACTOR shall defend,
15 at its sole cost and expense, including but not limited to attorney fees, cost of
16 investigation, defense and settlements or awards, COUNTY, its Agencies, Districts,
17 Special Districts and Departments, their respective directors, officers, Board of
18 Supervisors, elected and appointed officials, employees, agents and representatives in
19 any such action or claim. With respect to any action or claim subject to indemnification
20 herein by CONSULTANT, CONTRACTOR shall, at its sole cost, have the right to use
21 counsel of its own choice and shall have the right to adjust, settle, or compromise any
22 such action or claim without the prior consent of COUNTY; provided, however, that any
23 such adjustment, settlement or compromise in no manner whatsoever limits or
24 circumstances CONSULTANT's indemnification of COUNTY. CONSULTANT's
25 obligations hereunder shall be satisfied when CONTRACTOR has provided to COUNTY
26 the appropriate form of dismissal (or similar document) relieving the COUNTY from any
27 liability for the action or claim involved. The specified insurance limits required in this
28 Agreement shall in no way limit or circumscribe CONSULTANT's obligations to
29 indemnify and hold harmless the COUNTY.

1 SECTION 35. Insurance. CONTRACTOR shall, during the entire term of this
2 AGREEMENT:

3 a) Procure and maintain applicable Workers' Compensation Insurance as required
4 by the laws of the State of California; and

5 b) Procure and maintain automotive bodily injury and property damage liability
6 insurance and shall protect CONTRACTOR and COUNTY, listing those entities
7 described in Section 37 herein as additionally insured entities, from claims for damages
8 for personal injury, including accidental and wrongful death, as well as from claims for
9 property damage, which may arise from the performance of any actions associated with
10 this AGREEMENT. Such insurance shall provide for combined coverage limits of not
11 less than \$1,000,000 per occurrence; and

12 c) Procure and maintain commercial general liability insurance with combined
13 coverage limits of not less than \$5,000,000 per occurrence.

14 d) All insurance shall be purchased from companies authorized to do business in
15 the State of California.

16
17 SECTION 36. COUNTY's Reserved Rights -- Insurance. COUNTY reserves the
18 right to adjust the monetary limits of insurance coverage as required above in Section
19 35 above, commencing on the first anniversary of this AGREEMENT and on every
20 additional year thereafter during the remaining term of this AGREEMENT and any
21 extensions beyond the original year term.

22
23 SECTION 37. Certificate of Insurance and Additional Insured. CONTRACTOR
24 shall provide COUNTY with certificates of insurance demonstrating that insurance
25 limitations have been obtained from an insurance carrier authorized to sell insurance in
26 the State of California. Said certificates of insurance shall list the "Riverside County Fair
27 and National Date Festival, The County of Riverside, The Economic Development
28 Agency of the County of Riverside, the County of Riverside Asset Leasing Corporation
29 (CORAL)" and their officers, employees and agents as additionally insureds.
30

1 SECTION 38. Maintenance. CONTRACTOR shall continuously maintain the area
2 around each ride, show, and game and food concession in a clean, neat and safe
3 condition. After the FAIR, CONTRACTOR shall also clean up all areas used to the
4 satisfaction of COUNTY.

5
6 SECTION 39. Toxic Materials. During the term of this AGREEMENT,
7 CONTRACTOR shall not violate any federal, state, or local law, ordinance, or
8 regulation, relating to industrial hygiene or to the environmental condition of including,
9 but not limited to, soil and ground water conditions. Further, CONTRACTOR shall not
10 use, generate, manufacture, produce, store or dispose of on, under or about the
11 FACILITY or transport to or from the FACILITY, any flammable explosives, asbestos,
12 radioactive materials, hazardous wastes, toxic substances or related injurious materials,
13 whether injurious by themselves or in combination with other materials (collectively,
14 "hazardous materials"). For the purpose of this AGREEMENT, hazardous materials
15 shall include, but not limited to, substances defined as "hazardous substances", or "toxic
16 substances" in the Comprehensive Environmental Response Compensation and
17 Liability Act of 1980, as amended, 42 U.S.C. Section 9601, et seq.; the Hazardous
18 Materials Transportation Act, 49 U.S.C. Section 1801, et seq.; the Resource
19 Conservation and Recovery Act, 42 U.S.C. Section 6901, et seq.; and those substances
20 defined as "hazardous wastes" in Section 25117 of the California Health and Safety
21 Code or as "hazardous substances" in Section 25316 of the California Health and
22 Safety Code; and in the regulations adopted in publications promulgated pursuant to
23 said laws. **The CONTRACTOR shall not be liable for mitigation of any toxic
24 materials located on the FACILITY prior to the execution of this AGREEMENT**

25
26 SECTION 40. COUNTY's Representative. County hereby appoints the Economic
27 Development Agency Executive Director, or his or her successor, as its authorized
28 representative to administer this AGREEMENT.
29
30

1 SECTION 41. CONTRACTOR's Representative. CONTRACTOR hereby appoints

2 Richard Byrum Title Vice President

3 As its authorized representative to administer this LEASE.

4
5 SECTION 42. Notices. All notices, statements, demands, requests, consents,
6 approvals, authorizations, offers, agreements, appointments or designations hereunder
7 by either party to the other shall be in writing and shall be sufficiently given and served
8 upon the other party sent by United States registered mail, return receipt requested,
9 postage prepaid and addresses as follows:

23 SECTION 43. Discrimination or Segregation.

24 a) CONTRACTOR shall not discriminate in CONTRACTOR's recruiting, hiring,
25 promotion, demotion or termination practice on the basis of sex, race, religious creed,
26 color, national origin, ancestry, age, physical handicap, medical condition, or marital
27 status with respect to its use of the FACILITY hereunder, and CONTRACTOR shall

12 agreed that all persons hired or engaged by CONTRACTOR shall be considered
13 employees, independent contractors or agents of CONTRACTOR and not of COUNTY.

14
15 SECTION 45. Severability. The invalidity of any provision in this AGREEMENT as
16 determined by a court of competent jurisdiction shall in no way effect the validity of any
17 other provision herein.

18
19 SECTION 46. Free from Liens. CONTRACTOR shall pay, when due, all sums of
20 money that may become due for any labor, services, material, supplies, or equipment,
21 alleged to have been furnished or to be furnished to CONTRACTOR, in, upon, or about
22 the FAIRGROUNDS, and which may be secured by a mechanics', material men's or
23 other lien against the FAIRGROUNDS or COUNTY's interest therein, and will cause
24 each such lien to be fully discharged and released at the time the performance of an
25 obligation secured by such lien matures or becomes due; provided, however, that if
26 CONTRACTOR desires to contest any such lien, it may do so, but not withstanding any
27 such contest, if such lien shall be reduced to final judgment, and such judgment or such
28 process as may be issued for the enforcement thereof is not promptly stayed, or if so
29 stayed, and said stay thereafter expires, then and in such event, CONTRACTOR shall
30 for with pay and discharge said judgment.

1 SECTION 47. Ownership. COUNTY represents and warrants that COUNTY is
2 the owner of, and holds title to, FAIRGROUNDS.

3
4 SECTION 48. Governing Law and Venue. Any action at law or in equity brought
5 by either of the parties hereto for the purpose of enforcing a right or rights provided for
6 by this AGREEMENT shall be tried in a court of competent jurisdiction in the County of
7 Riverside, State of California, and the parties hereby waive all provisions of law
8 providing for a change of venue in such proceedings to any other County. This
9 Agreement and any dispute arising hereunder shall be governed by and interpreted in
10 accordance with the laws of the State of California. The parties shall be obligated to
11 attend a mediation session prior to the filing of any legal action.

12
13 SECTION 49. Paragraph Headings. The paragraph headings herein are for the
14 convenience of the parties only, and shall not be deemed to govern, limit, modify or in
15 any manner affect the scope, meaning or intent of the provisions or language of this
16 AGREEMENT.

17
18 SECTION 50. Waiver of Performance. No waiver by COUNTY at any time of any
19 of the terms and conditions of this AGREEMENT shall be deemed or construed as a
20 waiver at any time thereafter of the same or of any other terms or conditions contained
21 herein or of the strict and timely performance of such terms and conditions.

22
23 SECTION 51. Compliance with Laws and Regulations. By executing this
24 Agreement, the CONTRACTOR hereby certifies that it will adhere to and comply with all
25 federal, state and local laws, rules and regulations.

26
27 SECTION 52. Authority to Execute. The persons executing this Agreement or
28 exhibits attached hereto on behalf of the parties to this Agreement hereby warrant and
29 represent that they have the authority to execute this Agreement and warrant and
30 represent that they have the authority to bind the respective parties to this Agreement to
31 the performance of its obligations hereunder.

1 SECTION 54. Entire Agreement. This AGREEMENT constitutes the entire,
2 complete and final expression of agreements between the parties. This AGREEMENT
3 may be changed or modified only upon the written consent of the parties hereto.
