BACKGROUND:

This Fourth Amendment will provide an additional three (3) year, performance period for this contract. This contract's performance period will then be in alignment with the American Medical Response (AMR) Master Agreement, three (3) year extension, approved by the Board on, Tuesday, June 12, 2012, Agenda Item #3.10.

FOURTH AMENDMENT TO THE AGREEMENT**WITH****SPRINGS AMBULANCE SERVICE, INC.
DBA BLYTHE AMBULANCE SERVICE****(Emergency Ambulance Service)**

The Agreement between the COUNTY OF RIVERSIDE (COUNTY) and Blythe Ambulance Service (CONTRACTOR) was first approved on June 11, 2002 Item 3.14, amended for the first time on October 25, 2005, for the second time on June 24, 2008, and a third time on June 7, 2011, is hereby amended for a fourth time effective July 1, 2012 with the following:

1. Extend the performance period from July 1, 2008 through June 30, 2011 to July 1, 2012 to June 30, 2015.
2. Add Item 2.13.1 under Section 2—OBLIGATIONS OF CONTRACTOR which states: Contactor shall provide Riverside County EMS Agency with Computer Aided Dispatch (CAD) access within 30 days of executing this Fourth Amendment to the Agreement.
3. All other terms and conditions of this Agreement and previous Amendments are to remain unchanged.
