**BACKGROUND:** On June 19, 2012, a public hearing was held to receive all testimony regarding the annexation of Zone 165 to Landscaping and Lighting Maintenance District No. 89-1-Consolidated ("L&LMD No. 89-1-C"). After closing the public hearing, the Board directed the Director of Transportation, or his/her designee, to tally the assessment ballots that had been received prior to the close of the hearing.
