BACKGROUND:

The Transportation Improvement Program (TIP) provides for traffic signal modification and roadway widening at the intersection of Limonite Avenue and Etiwanda Avenue, in the City of Jurupa Valley. The proposed project will increase traffic capacity and improve traffic safety. In addition to the signal modification, the proposed improvements include widening the north side of Limonite Avenue, east of Etiwanda Avenue, to convert an existing westbound right turn lane into a through lane, which will increase capacity and reduce delay at the intersection. Other improvements consist of a sidewalk, ADA conforming access ramps at all four corners of the intersection, and a raised median on the east leg, which will reduce conflicts by prohibiting left-turning movements near the intersection,

Funds were budgeted and construction drawings were substantially completed prior to incorporation of the City of Jurupa Valley. The City of Jurupa Valley desires that the County continue as lead agency through project completion and they have approved the construction drawings.

The signal will be maintained by the City of Jurupa Valley.

The submitted plans and specifications have been approved as to form by County Counsel.

Environmental clearance is complete.
