**BACKGROUND:** Community Improvement Designation funds will be given to: Path of Life Ministries to assist their shelter; HOPE, Inc to support their food pantry program, RCCD Foundation to support their Fall 2012 Athletic Programs, The City of Riverside Park Recreation and Community Services- Rhythm of Riverside Spice to support a free family event in the Casa Blanca community, CHARLEE (Children Have All Rights; Legal, Educational and Emotional) Family Care's Walk a Mile in a foster Child's Shoes event to be held at Fairmount Park in Riverside to support this organization on their mission to serve children of abuse, neglect and abandonment; The City of Riverside Park Recreation and Community Services- Mariachi Festival which celebrates the City of Riverside's cultural history with a fun family event at Fairmount Park; in support of Community Settlement Association's 100<sup>th</sup> Anniversary of serving the Riverside community; American Cancer Society/Inland Empire Unit's Give Cancer the Boot to benefit the American Cancer Society and their efforts; Riverside Police Association's Charity Golf Classic to benefit the association's many programs and to support the 2<sup>nd</sup> Annual Citrus Classic Bike Ride- a fun family event to benefit the Riverside Educational Enrichment Foundation and the Alvord Educational Enrichment Foundation.

**I request that the Board of Supervisors approve a contribution of \$28,200 to support these programs.**
