BACKGROUND:

The Transportation Improvement Program (TIP) provides for resurfacing of these roads in Coachella Valley, which are in poor condition. The existing pavement on these roads will be pulverized in place and recycled as base material for the new road surface. The new asphalt pavement will range from 3 ½" to 5 ½" for the four roads. The roads will be improved with a wedged pavement edge at the shoulders, at fill section locations, to help reduce rollover accidents. The new road surface will extend the life of the road. Additional work will include flush graded shoulders, new striping, thermoplastic pavement markings and other associated work as necessary.

The road segments included in Group A are as follows:

ROAD	SEGMENT LOCATION	LENGTH
54 TH Ave	Jackson St. to Van Buren St	1.0 miles
66 th Ave	Jackson St. to Van Buren St	0.9 miles
76 th Ave	Harrison St. to E'ly to school parking lot	0.3 miles
81 st Ave	Harrison St. to SH 86 S	0.3 miles

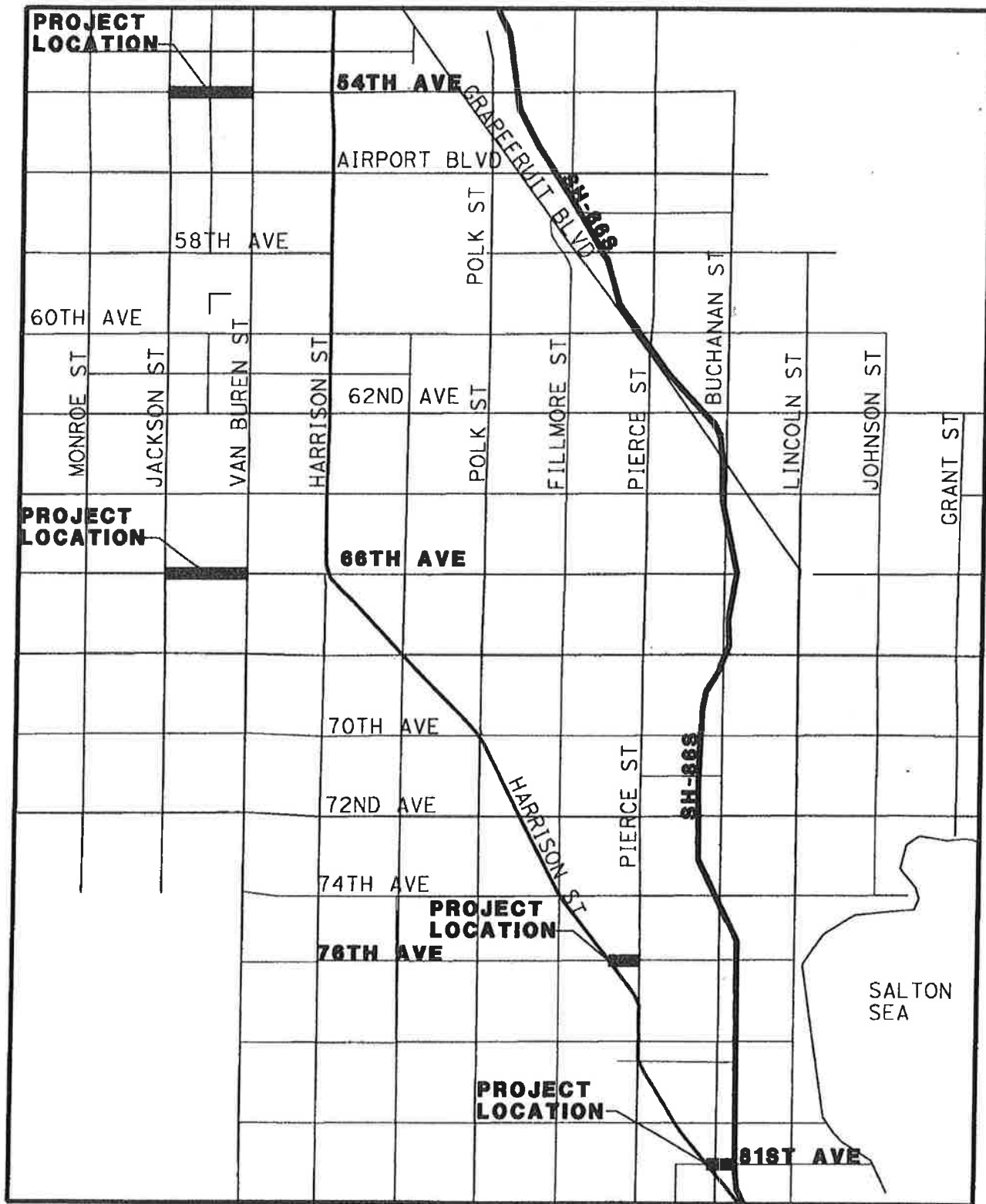
Group A is the first of nine roads in the Coachella Valley area scheduled for resurfacing improvements in FY 2012/2013. The other five roads are in design with construction anticipated for spring, 2013.

The submitted plans and specifications have been approved as to form by County Counsel.
