RECOMMENDED MOTION: That the Board of Supervisors authorize the Economic Development Agency to negotiate for new office building space for the Office of County Counsel in the Indio area near the location of the current Indio County Administrative Center.

BACKGROUND: On March 27, 2012, the Board of Supervisors approved acceptance of a funding award from the California Corrections Standard Authority for funds to plan and construct the new East County Detention Center, which will be constructed on the site of the current County Administrative Center in the City of Indio. The Office of County Counsel currently has staff occupying space in the Indio CAC and will need to relocate in order for demolition of the current facility and construction of the new East County Detention Center to move forward. The Economic Development Agency's Real Estate Division has published a Request For Proposal requesting submittals for the development of a new leased office building.
