SUBJECT: Amendment to the Professional Medical Services Agreement between the County of Riverside and Loma Linda University Healthcare

RECOMMENDED MOTION:

- 1) Ratify the Fifth (5th) Amendment to the Agreement with Loma Linda University Healthcare, effective July 1, 2012;
- 2) Authorize the Chairperson to sign three (3) copies of the amendment;
- 3) Retain one (1) copy and return two (2) copies of the executed amendments to Riverside County Regional Medical Center (RCRMC) for distribution.

BACKGROUND: On July 26, 2002, agenda item no. 3.17, an agreement was approved with Loma Linda University Healthcare to provide comprehensive Otolaryngology, Head and Neck (ENT) professional services to patients at RCRMC on an inpatient, outpatient, and emergency basis.

The agreement has been amended to expand the professional services provided by Loma Linda University Healthcare to include Oral and Maxillofacial surgical and clinical services. The added services include oral surgery related consults, outpatient clinic services, and on-call coverage for trauma services. An oral surgeon will be available to provide extraction services for patients requiring urgent medical dental extractions.

The amendment has been approved as to form by County Counsel.

FIFTH AMENDMENT
TO THE
PROFESSIONAL MEDICAL SERVICES AGREEMENT
BETWEEN
COUNTY OF RIVERSIDE
AND
LOMA LINDA UNIVERSITY HEALTHCARE

That certain Agreement between the County of Riverside (COUNTY) on behalf of the Riverside County Regional Medical Center (HOSPITAL) and Loma Linda University Healthcare (CONTRACTOR) dated July 1, 2002, and amended on July 1, 2004, January 1, 2005, August 1, 2010 and January 10, 2012 is hereby further amended effective July 1, 2012, pursuant to the following:

1. Amend all references to "Otolaryngology, Head and Neck Physicians" and replace to state "Otolaryngology, Head and Neck Physicians, Oral and Maxillofacial Surgery Physician services".

2. Add the following sentence to the end of Section 2.2 A:

"Provide adequate staffing to assume medical care responsibilities, including call coverage, for oral maxillofacial trauma surgery professional services along with oral surgery consults and dental extractions. CONTRACTOR shall provide two (2) half-day outpatient dental clinic services per week."

3. Delete Section 1.0, Exhibit A in its entirety and replace with the following:

"1.0 Subject to the conditions set forth below, HOSPITAL shall pay CONTRACTOR a total of five hundred sixty thousand (\$560,000) dollars per year for administrative, supervisory, teaching services, direct patient care, and professional otolaryngology, head and neck surgery, and oral maxiofacial trauma and oral surgery services provided at HOSPITAL. At a minimum, there must be one and one-half (1.50) full-time equivalent (FTE) physicians at HOSPITAL to oversee the otolaryngology, head and neck surgery clinic and perform surgeries and one (1) dentist/oral surgeon to provide dental extraction surgical services along with two (2) half-day outpatient clinics for dental/oral surgery related issues along with pre and post oral surgery surgical services. In addition, CONTRACTOR shall provide Audiology Services on-site for three (3) half-day clinics per week. The total payment includes an incentive for meeting performance requirements listed in Section 1.2 below. Payments to CONTRACTOR shall be made on a monthly basis during the Term of the Agreement. HOSPITAL shall pay CONTRACTOR payments by the invoice method specified below."

3. Delete Section 3.0, Exhibit A in its entirety and replace with the following:

“3.0 Maximum Annual Compensation

Maximum annual compensations payable under this Agreement shall not exceed five hundred sixty thousand (\$560,000) dollars. In the event the medical program provides coverage and payment for diagnostic audiological services, the parties agree (\$20,000) will be reduced from the maximum annual compensation.”

All other terms and conditions of this Agreement are to remain unchanged.

IN WITNESS WHEREOF, the Parties hereto have caused their duly authorized representatives to execute this Amendment.
