**BACKGROUND:** The Transportation Improvement Program provides for the construction of a traffic signal and street improvements at the intersection of Rubidoux Boulevard and 28<sup>th</sup> Street in the City of Jurupa Valley. The proposed traffic signal will improve safety by providing protected traffic movements and pedestrian crossings.

The proposed road improvements include reconstructing a 0.3 mile segment of Rubidoux Boulevard. Additional work includes placement of curb and gutter, pavement markers, roadside signs, installing painted traffic stripes and thermoplastic crosswalks and pavement markings and any other work as may be required.

A grant was approved, funds were budgeted and construction drawings were substantially prepared prior to incorporation of the City of Jurupa Valley. The City of Jurupa Valley desires that the County complete delivery of this project.

Funding for construction of these improvements is being provided in part from Federal Highway Safety Improvement Program funds for which the County successfully competed.

In addition, the Development Impact Fee (DIF) program, which is governed under Ordinance 659.6, allows for the use of DIF funds for traffic signal facilities.

Traffic signal will be operated and maintained by City of Jurupa Valley.

The submitted plans and specifications have been approved as to form by County Counsel.

Environmental clearance is complete.
