

BACKGROUND:

The CVAG Homelessness Committee will be authorizing the purchase of bus passes from Sun Line Transit Agency for the benefit of local homelessness service providers. Clients will be able to utilize the Sun Bus to access supportive services, seek employment, and other essential services to allow them to become self-sufficient.

Volunteers in Medicine is a volunteer clinic that provides free medical and dental care for underemployed individuals who cannot afford to purchase private insurance or do not qualify for Medi Cal.

The Economic Development Agency will be hosting four community fairs at the community centers located in the unincorporated communities of: North Shore, Indio Hills, Bermuda Dunes, and Mesa Verde.

Catholic Charities will be hosting their annual Evening of Hope event on November 3rd. The event raises funds to support the social service programs that assist families deal with crisis.

Family Services of the Desert is a non-profit organization that provides counseling to individuals and families in crisis.

I would like to use Fourth District Community Improvement Designation funds to assist these organizations in meeting the needs of our communities.
