BACKGROUND: (Continued)

Subsequently the Riverside County Fire Department issued a Request for Quote for furniture in February 2012. The contract was awarded to McMahan Business Interiors in the amount of \$31,862 for the purchase of interior office furniture; as well as Tuff Stuff Fitness Equipment, Inc., in the amount of \$17,148 for the fitness equipment.

The funds payable to McMahan Business Interiors and Tuff Stuff Fitness Equipment will not be an additional cost to the project as it is accounted for in the approved budget and a budget adjustment is not required. Furnishings for the new facility are reflected on the Recognized Obligation Payment Schedule (ROPS), which has been approved by the Oversight Board and the California Department of Finance. Staff recommends approval of the motions listed above.


