## **BACKGROUND:**

On January 10, 2012, the Board made conclusions and findings in the above-referenced matter. The Board ordered the property owners to abate the violative conditions on the property and directed County Counsel to prepare Findings of Fact, Conclusions and Order to Abate. On October 16, 2012, after several continuances, the Board adopted the submitted Findings of Fact, Conclusions and Order to Abate and authorized the Clerk of the Board to record the document.

However, during the public hearing on this matter in January, Supervisor Ashley requested that County staff "work with" the property owners to come into compliance. In the spirit of the request, County staff committed to hold off on recording the findings and order so long as the property owner remained diligent in seeking land use approvals and permits.

Inadvertently, the findings and order for this matter was promptly recorded with two other findings of fact that were also adopted by the Board on October 16th. Once recorded, the only way to withdraw the findings and order is for the Board to authorize recordation of the attached document with the Riverside County Recorder.
