SUBJECT: Authorization to Reissue County Stale-Dated Warrants #2013 - 2

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Authorize the re-issuance of County Stale-Dated Warrants pursuant to Government Code Section 29802.
- 2) Approve and direct the Auditor-Controller to make the budget adjustments as shown in Schedule A attached.

BACKGROUND:

Governmental Code 29802 requires a warrant to become void (stale-dated) if it has not been presented for payment to the County Treasurer within six months after the issuance date. Within two years from the date on which the original warrant becomes void, the payee or assignee of any warrant may request for the warrant to be reissued. (Continued on Page 2)

BACKGROUND Continued:

Board Resolution 82-278 (amended Board Agenda 3.5 8/6/1996) requires Board of Supervisors approval for amounts \$10,000 and greater. Warrants older than the two-year period also require Board approval.

The total amount in attachment "A" of \$106,086 represents \$39,905 in stale-dated warrants over two-years old, \$66,130 in stale-dated warrants over \$10,000 and \$51 in requests from departments to return funds related to stale-dated warrants over two-years old.

A budget adjustment of \$1,160 for Maria & John Corcoran is required to reissue a stale-dated warrant that was returned to the general fund.
