3. Adopt Successor Agency Resolution No. 2012-014, Approval of the Lease and Operating Agreement between Successor Agency to the Redevelopment Agency for the County of Riverside and Family Services Association;
4. Approve the attached Lease and Operating Agreement and authorize the Chairman of the Board to execute same on behalf of the Successor Agency;
5. Authorize the Assistant County Executive Officer/EDA, or designee, to take all necessary steps to implement the Lease and Operating Agreement including signing subsequent, necessary related documents to complete this transaction;
6. Direct the Clerk of the Board to post the Notice of Exemption; and
7. Direct staff to submit the agreement to the Oversight Board for formal review and approval.

BACKGROUND:

The Successor Agency to the Redevelopment Agency for the County of Riverside is the owner of record of the Rubidoux Child Development Center consisting of approximately 14,336 square feet plus adjacent parking lot area located at 3865 Riverview Drive, in the city of Jurupa Valley. The Successor Agency desires to operate a Child Care Center at the property and enter into a Lease and Operating Agreement with a Child Care Provider.

The County desires to lease the property to the Family Service Association (FSA), a California non-profit corporation, to operate the Rubidoux Child Development Center. FSA will provide Child Care Services and other related programs.

The term of the agreement shall be for a five year period commencing on the Effective Date and may be extended with proper notice for three separate five year periods. FSA shall pay \$1,500.00 per month to the County for the initial term of the agreement which shall constitute rent under this agreement.

Notice of the public hearing has been published pursuant to the requirements of Health and Safety Code § 33431 and Government Code § 6066. A report pursuant to Health & Safety Code § 33433 has been prepared and made available for review and is attached to this Form 11.

Pursuant to the California Environmental Quality Act (CEQA) Guidelines Section 15301, Existing Facilities Class 1 and General Rule Exemption Section 15061, a Notice of Exemption will be filed with the County Clerk. The proposed project, the Lease and Operating Agreement, is the letting of property involving existing facilities and no expansion of existing use will occur.

This Form 11, Resolution as well as the Lease and Operating Agreement have been reviewed and approved by County Counsel as to legal form.

**AUTHORIZATION TO LEASE REAL PROPERTY FROM THE SUCCESSOR
AGENCY TO THE FAMILY SERVICE ASSOCIATION
(Second District)**

I. WHEREAS, the Successor Agency to the Redevelopment Agency for the County of Riverside (Successor Agency) is the owner of record of certain real property located at 3865 Riverside Drive, Riverside County, California (the "Property"), which is more particularly described in Exhibit A, attached and incorporated herein by reference.

II. WHEREAS, the Redevelopment Agency for the County of Riverside formerly owned that certain real property located at 3865 Riverview Drive, Riverside County, California (the Property), which is more particularly described in the legal description as set forth in Exhibit A as Parcel B, attached and incorporated herein by reference;

III. WHEREAS, the Riverside County Board of Supervisors formerly adopted redevelopment plans for Redevelopment Project Area Nos. 1-1986, Jurupa Valley, Mid-County, Desert Communities and the I-215 Corridor, as amended, (the "Project Areas");

IV. WHEREAS, pursuant to Section 33670 of the Health and Safety Code, the Agency formerly began receiving tax increment from the Project Areas in January 1988, and continued to receive annual tax increment revenue;

V. WHEREAS, pursuant to Section 33430 of the Health and Safety Code, the Agency could within the survey area or for purposes of redevelopment sell, lease, exchange, subdivide, transfer, assign, pledge or otherwise dispose of any real or personal property or any interest in property;

VI. WHEREAS, the leasing of the Property by the Successor Agency is exempt from the California Environmental Quality Act ("CEQA") pursuant to CEQA

1 Guideline Section 15301 because the use set forth herein is not an expansion of the
2 use beyond that considered in the Negative Declaration;

3 VII. WHEREAS, the Property includes the newly completed Rubidoux Child
4 Development Center (the "Center"), which consists of one 14,336 square foot building
5 and adjacent landscaping, parking lot, and thirty (30) parking spaces, as depicted on
6 Exhibits "B" and "C", attached , and incorporated herein by reference;

7 VIII. WHEREAS, the State Legislature passed AB X1 26 and AB X1 27 in the
8 2011-2012 Legislative Session which authorized either a total dissolution of the
9 Redevelopment Agencies in the State of California or would authorize the
10 Redevelopment Agencies to operate on the condition they agree to compensate the
11 state on an annual basis;

12 IX. WHEREAS, on July 18, 2011, the California Redevelopment Association
13 and the California League of Cities filed a petition with the State Supreme Court to
14 overturn this legislation;

15 X. WHEREAS, the California State Supreme Court, on December 29, 2011,
16 upheld AB X1 26 allowing the State to dissolve the agencies effective February 1,
17 2012, and striking down AB X1 27, which would have allowed the agencies the option
18 to continue to operate provided they compensate the State;

19 XI. WHEREAS, AB X1 26 provides that Redevelopment assets will be
20 transferred by operation of law to a Successor Agency;

21 XII. WHEREAS, the Successor Agency to the former Redevelopment Agency
22 for the County of Riverside is a separate public entity;

23 XIII. WHEREAS, Successor Agency desires to assist in providing facilities for
24 the Center that are in the vital and best interest of the residents of Rubidoux and
25 Jurupa Valley area;

26 XIV. WHEREAS, FSA Child Development Services offers a variety of
27 programs for children and their families;

1 XV. WHEREAS, FSA's Child Development Centers provide a safe,
2 stimulating and enriching environment with highly qualified and dedicated staff, to care
3 for children from infancy through preschool age;

4 XVI. WHEREAS, FSA programs provide activities and opportunities to develop
5 independence in an environment that encourage growth and positive self-awareness;

6 XVII. WHEREAS, FSA programs offer opportunities for appropriate social
7 interactions, in a loving atmosphere that develops respect for self and property;

8 XVIII. WHEREAS, Each FSA Center provides a well-balanced curriculum with
9 emphasis on children's social/emotional skills in an enriched cognitive environment.
10 This setting ensures that children's needs (intellectual, physical, emotional, social and
11 creative) are appropriately met at a variety of levels;

12 XIX. WHEREAS, each FSA Center encourages strong parental participation;

13 XX. WHEREAS, FSA desires a facility in which to provide childcare services
14 in the community of Rubidoux and Jurupa Valley to provide these services;

15 XXI. WHEREAS, FSA serves low and moderate income families;

16 XXII. WHEREAS, the purpose of this Agreement is to provide these services to
17 the community;

18 XXIII. WHEREAS, a report has been prepared and made available for public
19 review pursuant to Health and Safety Code Section 33433; and

20 XXIV. WHEREAS, the Successor Agency and FSA desire to enter into a
21 Lease and Operating Agreement for the Property in accordance with the terms and
22 conditions therein.

23 **NOW THEREFORE, BE IT RESOLVED, FOUND, DETERMINED, AND**
24 **ORDERED** by the Board of Supervisors of the County of Riverside, State of California,
25 as follows:

26 1. That the Board of Supervisors hereby finds and declares that the above
27 recitals are true and correct.

1 2. That the Lease and Operating Agreement between the Successor
2 Agency for the County of Riverside and the Family Services Association is approved.

3 3. That the Chairman of the Board of Supervisors is authorized to execute
4 the Lease and Operating Agreement, which is attached as Exhibit "A".

5 4. That the Assistant County Executive Officer/EDA or designee is hereby
6 authorized to take necessary steps to complete this transaction including executing
7 subsequent relevant and necessary documents, subject to County Counsel approval.

1 **RUBIDOUX CHILD DEVELOPMENT CENTER**

2 **LEASE AND OPERATING AGREEMENT**

3 This Lease and Operating Agreement (Agreement) is made by and between the
4 Successor Agency to the Redevelopment Agency for the County of Riverside, a
5 California public entity, corporate and politic (Successor Agency), and the Family
6 Service Association (FSA), a California non-profit corporation, sometimes jointly
7 referred to herein as the Parties, with reference to the following:

8 **RECITALS**

9
10 I. WHEREAS, the Redevelopment Agency for the County of Riverside
11 owned that certain real property located at 3865 Riverview Drive, Riverside County,
12 California (the Property), which is more particularly described in the legal description as
13 set force in Exhibit "A" as Parcel B, attached hereto and incorporated herein by
14 reference;

15 II. WHEREAS, the Riverside County Board of Supervisors formerly adopted
16 redevelopment plans for Redevelopment Project Area Nos. 1-1986, Jurupa Valley, Mid-
17 County, Desert Communities and the I-215 Corridor, as amended, (the "Project
18 Areas");

19 III. WHEREAS, pursuant to Section 33670 of the Health and Safety Code, the
20 Agency began receiving tax increment from the Project Areas in January 1988, and
21 continued to receive annual tax increment revenue;

22 IV. WHEREAS, pursuant to Section 33430 of the Health and Safety Code, the
23 Agency could within the survey area or for purposes of redevelopment sell, lease,
24 exchange, subdivide, transfer, assign, pledge or otherwise dispose of any real or
25 personal property or any interest in property;

26 V. WHEREAS, the Property includes the newly completed Rubidoux Child

11 VIII. WHEREAS, the matter was decided by the California Supreme
12 Court on December 29, 2011, upholding ABx1 26 allowing the dissolution of
13 redevelopment agencies effective February 1, 2012, and struck down ABx 1 27 which
14 would have allowed agencies the opt in to continue to operate pursuant to the
15 Voluntary Redevelopment Program;

16 IX. WHEREAS, the Successor Agency) is the successor in interest to the
17 former Redevelopment Agency for the County of Riverside;

18 X. WHEREAS, Successor Agency desires to assist in providing child care
19 services in the Center that are in the vital and best interest of the residents of Rubidoux
20 and Jurupa Valley area;

21 XI. WHEREAS, FSA Child Development Services offers a variety of programs for
22 children and their families;

23 XII. WHEREAS, FSA's Child Development Centers provide a safe,
24 stimulating and enriching environment with highly qualified and dedicated staff, to care
25 for children from infancy through preschool age;

26 XIII. WHEREAS, FSA programs provide activities and opportunities to develop
27 independence in an environment that encourage growth and positive self-awareness;

28

XIV. WHEREAS, FSA programs offer opportunities for appropriate social interactions, in a loving atmosphere that develops respect for self and property;

XV. WHEREAS, Each FSA Center provides a well-balanced curriculum with emphasis on children's social/emotional skills in an enriched cognitive environment. This setting ensures that children's needs (intellectual, physical, emotional, social and creative) are appropriately met at a variety of levels;

XVI. WHEREAS, each FSA Center encourages strong parental participation;

XVII. WHEREAS, FSA desires a facility in which to provide childcare services in the community of Rubidoux and Jurupa Valley to provide these services;

XVIII. WHEREAS, FSA serves low and moderate income families;

XIX. WHEREAS, the Successor Agency has acquired furniture, fixtures and equipment (Equipment) in support of providing child care services at the Center;

XX. WHEREAS, the purpose of this Agreement is to provide these services to the community; and

XXII. WHEREAS, the Successor Agency and FSA desire, by this Agreement, to enter into this Lease and Operating Agreement for the operation of a child care center on the Property in accordance with the terms and conditions of this Agreement.

NOW THEREFORE, the Parties hereby enter in to this Agreement and agree to the following:

COVENANTS

ARTICLE I

PROPERTY AND TERM

1.1 Effective Date. The Effective date of this Agreement is the date the parties execute the Agreement. If the parties execute the Agreement on more than one date, then the last date the Agreement is executed by a party shall be the Effective date.

1.2 Term. The term of this Agreement shall be for an initial period of five (5) years (the "Initial Term") commencing on the Effective date as defined in Section 1.1.

1 Thereafter, FSA may request three separate five year extension periods to (extension
2 term) this Agreement, provided they send written notice to Successor Agency of its
3 request within ninety (90) days prior to expiration of the original term or respective
4 Extension Term. The rent shall be increased three (3%) percent for each Extension
5 Term. In the event FSA fails to provide said notice, the Agreement shall terminate at
6 the expiration of the Initial Term or subsequent Extension Term

7 1.3 Acceptance of Property. FSA accepts the Property in an "as-is" and a
8 "where is" condition based solely on FSA's own studies and investigations on the
9 effective date of the commencement of the term of this Agreement.

10 **ARTICLE II**

11 **RENT, TAXES AND UTILITIES**

12 2.1 Rent. FSA shall pay \$1,500.00 per month to Successor Agency as rent
13 for the Center payable on the first day of each and every month during the Agreement
14 Term as set forth in section 1.2 of this agreement. In the event it is necessary to
15 prorate the rent, the rent shall be prorated on a thirty (30) day basis.

16 2.2 Taxes and Assessments. During the term of this Agreement, FSA also
17 agrees to pay, or cause to be paid, all applicable real and personal property taxes,
18 general and special assessments, and other charges of every description as may be
19 levied on or assessed against the Center, improvements to the Center, or personal
20 property owned by FSA and located on or in the Center to the extent that such taxes,
21 assessments and charges. FSA understands and agrees that it may be subject to a
22 possessory interest tax in accordance with the California Revenue and Taxation Code.

23 2.3 Utilities. During the term of this Agreement, FSA further agrees to pay, or
24 cause to be paid, all utilities used upon the Property including without limitation
25 including water, gas, heat, electrical, telephone service, refuse collection and removal,
26 and all other services supplied to the Center.

1 **ARTICLE III**

2 **USE, MAINTENANCE, COMPLIANCE WITH LAWS, OBLIGATIONS**

3 3.1 Limitations on Use. The Center shall be leased and operated by FSA for
4 the sole purpose of providing childcare services for the community and for the benefit
5 of residents and the general population of the community of Rubidoux and Jurupa
6 Valley.

7 3.2 Services to Low and Moderate Income Residents. FSA shall use its best
8 efforts to ensure that the child care services provided pursuant to this Agreement shall
9 be made available and accessible to the low and moderate income residents of the
10 community of Rubidoux, Jurupa Valley and Riverside County. FSA shall submit, a
11 written annual report of its compliance with this section to the Successor Agency each
12 year on or before the anniversary date of this Agreement in the form and manner
13 prescribed by the Successor Agency.

14 3.3. Food Services. In addition, FSA shall be permitted to engage in food
15 preparation services in connection with the childcare operations at the Center. FSA
16 shall also be permitted to engage in food preparation services to service their Mission
17 Villas Senior Center, as well as meals for homebound seniors only. No other food
18 preparation services may be provided by FSA at the Center.

19 3.4 No Liens or Easements. Except for permitted encumbrances,
20 easements, and restrictions approved in writing by Successor Agency, FSA agrees and
21 covenants not to place or allow to be placed any deed of trust, mortgage, or any other
22 type of lien upon the Property during the term of this Agreement without the written
23 consent of Successor Agency, which consent shall be in Successor Agency's absolute
24 discretion.

25 3.5 Maintenance of the Center. Successor Agency shall, at its sole cost and
26 expense, maintain, or cause to be maintained, the Center, including but not limited to
27 the mechanical, electrical, plumbing, and all operating systems including the parking lot
28 and landscaping in good condition and repair for the purposes in Section 3.1 and 3.2

1 above and in accordance with all applicable laws, including without limitation such
2 zoning, safety ordinances and laws, environmental regulations, and such rules and
3 regulations hereunder as may be binding upon Successor Agency.

4 3.6 Furniture, Fixtures and Equipment. Successor Agency and FSA agree
5 and acknowledge that the Successor Agency has provided and installed furniture,
6 fixtures and equipment for the operation of the Center and provision of child care
7 services (Equipment) as set forth in Exhibit "D" attached hereto and incorporated
8 herein. Such equipment includes, but is not limited to classroom equipment, office
9 equipment, furniture, and kitchen appliances. FSA shall, at its sole cost and expense,
10 be responsible for all necessary maintenance, repair and replacement of the
11 Equipment.

12 3.7 Compliance with Laws and Restrictions. FSA shall, at its sole cost and
13 expense, obtain any and all necessary permits and licenses, and shall fully comply with
14 all applicable ordinances, including building and zoning ordinances. FSA further
15 agrees to use the Center in compliance with all laws now in force or which may
16 hereafter be in force relative to its use as outlined in Section 3.1 above, including
17 without limitation compliance with all federal, state, and local statutes and regulations,
18 as well as all covenants, conditions, and restrictions contained in this Agreement.

19 3.8 Additional Obligations.

20 (a) FSA Obligations. FSA shall be obligated to provide childcare
21 programs and services to the community and the citizens of Riverside County including
22 but not limited to childcare services, and childcare recreational activities. The Center
23 shall be open, at a minimum, Monday through Friday from 6:00am - 6:00pm and may
24 be open evenings, weekends, and holidays at the discretion of FSA.

25 (b) FSA shall, at its sole cost and expense, be responsible for all
26 janitorial services.

1 **ARTICLE IV**
2 **FINANCING AND CONTRACTING WITH**
3 **THIRD PARTIES**

4 4.1 Contracting with Third Parties. FSA, in FSA's discretion, may enter into
5 Agreements and contracts for the purpose of providing janitorial services and in
6 connection with the uses required to be performed, by Section 3.1 above on the
7 Center, except that any and all Agreements and / or contracts for the use and
8 occupancy of space by third parties shall be subject to approval by Successor Agency
9 in Successor Agency's sole discretion. All such Agreements and contracts, to the
10 extent approved by Successor Agency, shall contain provisions necessary to protect
11 the Successor Agency, its officers, employees, successors, and assigns from any
12 liability arising out of the operation, maintenance or replacement of any improvements
13 and facilities in the Center as a result of such third party use or occupancy. The term
14 of any permit, contract, or other Agreement entered into by FSA affecting or related to
15 the Center shall not under any circumstances exceed the term of this Agreement.

16 4.2 No Assignment or Sublease. FSA shall not assign or sublease the
17 Property without the written consent of the Successor Agency. Such consent shall be
18 in the sole and absolute discretion of the Successor Agency.

19 **ARTICLE V**
20 **INSURANCE**

21 5.1 Insurance. Without limiting or diminishing the FSA's obligation to
22 indemnify and hold the Successor Agency harmless as set forth in section 10.1, FSA
23 shall procure and maintain or cause to be maintained, at its sole cost and expense, the
24 following insurance coverage's during the term of this Agreement:

25 (a). Workers' Compensation: If FSA has employees as defined by the
26 State of California, FSA shall maintain statutory Workers' Compensation Insurance
27 (Coverage A) as prescribed by the laws of the State of California. Policy shall include
28 Employers' Liability (Coverage B) including Occupational Disease with limits not less

1 than \$1,000,000 per person per accident. The policy shall be endorsed to waive
2 subrogation in favor of the Successor Agency, and, if applicable, to provide a Borrowed
3 Servant/Alternate Employer Endorsement.

4 (b). Commercial General Liability: Commercial General Liability
5 insurance coverage, including but not limited to, premises liability, contractual liability,
6 products and completed operations liability, personal and advertising injury, and cross
7 liability coverage, covering claims which may relate to, arise from or out of FSA's
8 performance of its obligations hereunder. Policy shall name the Successor Agency,
9 the County of Riverside, its Agencies, Districts, Special Districts, and Departments,
10 their respective directors, officers, Board of Supervisors, employees, elected or
11 appointed officials, agents or representatives as Additional Insured. Policy's limit of
12 liability shall not be less than \$1,000,000 per occurrence combined single limit. If such
13 insurance contains a general aggregate limit, it shall apply separately to this
14 Agreement or be no less than two (2) times the occurrence limit.

15 (c). Vehicle Liability: If vehicles or mobile equipment are used in the
16 performance of the obligations under this Agreement, then FSA shall maintain liability
17 insurance for all owned, non-owned or hired vehicles so used in an amount not less
18 than \$1,000,000 per occurrence combined single limit. If such insurance contains a
19 general aggregate limit, it shall apply separately to this Agreement or be no less than
20 two (2) times the occurrence limit. Policy shall name the Successor Agency, the
21 County of Riverside, its Agencies, Districts, Special Districts, and Departments, their
22 respective directors, officers, Board of Supervisors, employees, elected or appointed
23 officials, agents or representatives as Additional Insured.

24 (d). General Insurance Provisions - All lines:

25 1) Any insurance carrier providing insurance coverage
26 hereunder shall be admitted to the State of California and have an A M BEST rating of
27 not less than A: VIII (A:8) unless such requirements are waived, in writing, by the
28 Successor Agency's Risk Manager. If the Successor Agency's Risk Manager waives a

1 requirement for a particular insurer such waiver is only valid for that specific insurer
2 and only for one policy term.

3 2) The FSA's insurance carrier(s) must declare its insurance
4 self-insured retentions. If such self-insured retentions exceed \$500,000 per
5 occurrence such retentions shall have the prior written consent of the Successor
6 Agency's Risk Manager before the commencement of operations under this
7 Agreement. Upon notification of self-insured retention unacceptable to the Successor
8 Agency, and at the election of the Successor Agency's Risk Manager, FSA's carriers
9 shall either; 1) reduce or eliminate such self-insured retention as respects this
10 Agreement with the Successor Agency, or 2) procure a bond which guarantees
11 payment of losses and related investigations, claims administration, and defense costs
12 and expenses.

13 3) FSA shall cause FSA's insurance carrier(s) to furnish the
14 Successor Agency with either 1) a properly executed original Certificate(s) of Insurance
15 and certified original copies of Endorsements effecting coverage as required herein,
16 and 2) if requested to do so orally or in writing by the County's Risk Manager, provide
17 original Certified copies of policies including all Endorsements and all attachments
18 thereto, showing such insurance is in full force and effect. Further, said Certificate(s)
19 and policies of insurance shall contain the covenant of the insurance carrier(s) that
20 thirty (30) days written notice shall be given to the Successor Agency prior to any
21 material modification, cancellation, expiration or reduction in coverage of such
22 insurance. In the event of a material modification, cancellation, expiration, or reduction
23 in coverage, this Agreement shall terminate forthwith, unless the Successor Agency
24 receives, prior to such effective date, another properly executed original Certificate of
25 Insurance and original copies of endorsements or certified original policies, including all
26 endorsements and attachments thereto evidencing coverage's set forth herein and the
27 insurance required herein is in full force and effect. FSA shall not commence
28 operations until the Successor Agency has been furnished original Certificate (s) of

1 Insurance and certified original copies of endorsements and if requested, certified
2 original policies of insurance including all endorsements and any and all other
3 attachments as required in this Section. An individual authorized by the insurance
4 carrier to do so on its behalf shall sign the original endorsements for each policy and
5 the Certificate of Insurance.

6 4) If, during the term of this Agreement or any extension
7 thereof, there is a material change in the permitted use, the Successor Agency
8 reserves the right to adjust the types of insurance required under this Agreement and
9 the monetary limits of liability for the insurance coverage's currently required herein, if;
10 in the Successor Agency Risk Manager's reasonable judgment, the amount or type of
11 insurance carried by the FSA has become inadequate.

12 5) FSA shall pass down the insurance obligations contained
13 herein to all tiers of vendors working under this Agreement.

14 6) The insurance requirements contained in this Agreement
15 may be met with a program(s) of self-insurance acceptable to the Successor Agency.

16 7) FSA shall notify Successor Agency of any claim by a third
17 party or any incident or event that may give rise to a claim arising from the
18 performance of this Agreement within 10 days of receipt of notice thereof.

19 **ARTICLE VI**

20 **DAMAGE OR DESTRUCTON**

21 **DURING TERM OF AGREEMENT**

22 6.1 Restoration of Property. If during the term of this Agreement, the Center
23 is damaged, whether or not from a risk covered by insurance, and subject to the other
24 provisions of this Agreement regarding termination, Successor Agency shall have the
25 option, but shall not be obligated to make the repairs necessary to restore the Center
26 and all the improvements thereon, to a condition for occupancy or use comparable to
27 the condition thereof before such damage provided that if Successor Agency
28 determines in its sole discretion, that it is not feasible to do so, Successor Agency shall

1 have the right to terminate this Lease and Operating Agreement. .

2 **ARTICLE VII**

3 **DEFAULT AND TERMINATION**

4 7.1 Events of Default. The following events shall be a default by FSA (Event
5 of Default):

6 (a) Failure of FSA to perform or observe any provisions or
7 condition of this Agreement, including, but not limited to compliance with the uses
8 outlined in Section 3.1.

9 (b) The subjection of any material right or interest of FSA to
10 attachment, execution, or other levy, or to seizure under legal process which
11 would materially interfere with FSA's ability to comply with the required uses set
12 forth in Section 3.1 above in the Center.

13 (c) In the event the Center becomes a public nuisance or
14 disturbs the peace and tranquility of the surrounding residents as adjudicated by the
15 final judgment of a court of competent jurisdiction.

16 7.2 Notice and Right to Cure. Prior to pursuing any remedy for an alleged
17 default of FSA, Successor Agency shall provide written notice of default to FSA. Each
18 notice of default shall specify in detail the alleged "Event of Default" and the intended
19 remedy. FSA shall have thirty (30) days after notice is delivered (see Section 11.3:
20 Notices, below) to cure the alleged default. In the event that any non-monetary default
21 is of such a nature that the same cannot reasonably be cured within the thirty (30) day
22 period described above, then the cure period shall be extended by such further
23 reasonable period (not to exceed an additional 90 days) so long as FSA commences
24 the cure within the thirty (30) day period described above and thereafter diligently
25 prosecutes the cure to completion.

26 7.3 Remedies. In the event a material default by FSA continues uncured for
27 a period of thirty (30) days following written notice, unless a longer cure period is
28 provided pursuant to Section 7.2, in addition to the rights and remedies provided by law

or equity, Successor Agency may at its election terminate this Agreement by giving FSA written notice of termination. On the giving of notice of termination, all of FSA's rights to occupancy of the Property and improvements shall terminate. Promptly after notice of termination, FSA shall surrender and vacate the Property, Equipment, and all improvements in good and clean condition.

7.4 Early Termination by FSA. In the event that FSA's funding is withdrawn, FSA may terminate this Agreement by giving written notice to Successor Agency at least forty-five (45) days in advance. Upon such termination, FSA must surrender the Property, Equipment, and all improvements in good, clean and working condition.

ARTICLE IIX

ENVIRONMENTAL PROTECTION AND HAZARDOUS WASTE AND WATER QUALITY MANAGEMENT PLAN

8.1 Environmental Protection. FSA shall not discharge, dispose of, or permit to escape, any drainage water, non-point source runoff, raw sewage, fuel, or waste of any kind, within or outside the Center that could result in destruction of habitat or the contamination or pollution of said Center. FSA shall at all times comply with all applicable federal, state, and local laws, orders, and regulations, as may be amended with respect to the proper discharge of refuse, garbage, sewage effluent, wastes, storm water runoff, and any and all other pollutants, including soil sediments, and shall cause its employees, agents and other persons or entities under its control to comply fully with such laws, orders, and regulations.

8.2 Hazardous Materials. FSA shall not use or allow anyone else to use the Center to generate, manufacture, refine, transport, treat, store, handle, recycle, release, or dispose of any hazardous material, other than as reasonably necessary for the operation of its operations and activities as contemplated under this Agreement . The term "hazardous material" means any hazardous substance, material, or waste including, but not limited to, those listed in 49 CFR 172.101 (U.S. Department of Transportation), the Cal/EPA Chemical Lists, or petroleum products and their

1 derivatives. However, this shall not apply to the use of petroleum products and related
2 substances incidental to operation of motorized equipment and vehicles whose
3 operation on the premises is contemplated by this Agreement. FSA shall immediately
4 notify Successor Agency in writing in the event of any release of hazardous material,
5 violation of any environmental law, or actions brought by third parties against FSA
6 alleging environmental damage. FSA shall indemnify and hold Successor Agency
7 harmless from any and all damages of any nature (including payment of attorney fees)
8 related to or arising out of the discharge or release of hazardous materials caused by
9 FSA or any person or entity under its control. Successor Agency represents and
10 warrants to FSA that, to the best of Successor Agency knowledge, no hazardous
11 material has been generated, manufactured, refined, transported, treated, stored,
12 handled, recycled, released, or disposed of on, under, or about the Center or Property
13 prior to the effective date of this Agreement. In the event that FSA discovers that any
14 hazardous material has been generated, manufactured, refined, transported, treated,
15 stored, handled, recycled, released, or disposed of on, under, or about the Center or
16 Property prior to the effective date of this Agreement, then FSA shall have the right to
17 immediately terminate this Agreement and shall have no remediation responsibility,
18 and Successor Agency shall indemnify, defend and hold harmless FSA from any and
19 all liability of any type related thereto, including attorney's fees.

20 8.3 Water Quality Management Plan. Successor Agency shall be
21 responsible for the operation and management of best management practices (BMPs)
22 as set forth in Exhibit "E" associated with the Property's Water Quality Management
23 Plan for the term of this Agreement. Successor Agency shall be responsible for any
24 fine, penalty, or any other civil, administrative or criminal liability resulting from
25 Successor Agency failure to maintain the BMPs, except in the event FSA's action or
26 inaction contributes to or in any way creates a maintenance issue or detrimentally
27 affects Successor Agency ability to maintain the BMP's, then FSA shall be responsible
28

1 for any fine, penalty, or any other civil, administrative or criminal liability resulting from
2 a failure to maintain the BMPs.

3 **ARTICLE IX**

4 **SURRENDER AND DISPOSITION OF PROPERTY**

5 9.1 Surrender of Property. Upon the expiration or earlier termination of this
6 Agreement, FSA shall surrender the Center to the Successor Agency and all
7 improvements and Equipment in a good, clean and working condition, subject to
8 reasonable wear and tear.

9 9.2 Disposition of FSA's Property upon Termination. Upon the expiration or
10 earlier termination of this Agreement, any improvements constructed in the Center by
11 FSA (other than trade fixtures or other removable fixtures) shall become the property of
12 Successor Agency at no cost or expense to Successor Agency.

13 **ARTICLE X**

14 **INDEMNIFICATION**

15 10.1 Indemnification by FSA. FSA shall defend, indemnify, and hold
16 Successor Agency harmless from, and reimburse Successor Agency for, any loss,
17 cost, expense, liability, or damages of every kind or nature, including but not limited to
18 injury to or death of any person or destruction of property in connection with or in any
19 way related to, the use by FSA or any third party of the Center or any facilities located
20 thereon, except to the extent of the negligent or intentional acts or omissions of, or the
21 breach of this Agreement or violation of applicable laws by, the Successor Agency or
22 its officers, directors, employees, agents or contractors, and further excepting any
23 claims arising from the presence, discharge or release of hazardous materials
24 occurring prior to the effective date of this Agreement. In addition, FSA shall defend,
25 indemnify, and hold Successor Agency harmless from any breach or default in the
26 performance of any obligation to be performed by FSA under this Agreement, any
27 violation of governmental law or regulation, or any intentional misconduct or negligence
28 of FSA, or any officer, agent, employee, guest, or invitee of FSA, regardless of

1 whether such intentional misconduct or negligence was active or passive, and except
2 to the extent of the negligent or intentional acts or omissions of, or the breach of this
3 Agreement or violation of applicable laws by, the Successor Agency or its officers,
4 directors, employees, agents or contractors and further excepting any claims arising
5 from the presence, discharge or release of hazardous materials occurring prior to the
6 effective date of this Agreement.

7 10.2 Successor Agency's Duties: In the event of the occurrence of any event
8 that is an indemnifiable event pursuant to this section, Successor Agency shall notify
9 FSA in writing promptly and, if such event involves the claim of any third person, FSA
10 shall assume all expenses with respect to, the defense, settlement, adjustment, or
11 compromise of any claim, provided that the Successor Agency may, if it so desires,
12 employ counsel at its own expense to assist in the handling of such claim, and FSA
13 shall obtain the prior written approval of the Successor Agency, which shall not be
14 unreasonably withheld, before entering into any settlement, adjustment or compromise
15 of such claim. FSA shall reimburse the Successor Agency or any third party (including
16 officers, directors, and employees of the Successor Agency) for any reasonable legal
17 expenses and costs incurred in connection with or in enforcing the indemnity herein
18 provided.

19 10.3 Survival of Indemnification Requirements. All indemnification obligations
20 hereunder shall survive the expiration or earlier termination of this Agreement.

21 **ARTICLE XI**

22 **MISCELLANEOUS PROVISIONS**

23 11.1 Governing Law. This Agreement shall be governed by and construed in
24 accordance with the laws of the State of California.

25 11.2 Severability. Each section and provision of this Agreement is severable
26 from each other provision, and if any provision In the event that any one or more of the
27 provisions contained in this Agreement shall be invalid, illegal or unenforceable in any
28 respect, the validity, legality, and enforceability of the remaining provisions contained in

1 this Agreement shall not in any way be affected or impaired thereby. To the extent
2 permitted by applicable law, each party to this Agreement waives any provision of law
3 that renders any provision of this Agreement invalid, illegal, or unenforceable in any
4 respect. In the event any provision of this Agreement shall be held invalid, illegal, or
5 unenforceable, the parties shall use all reasonable efforts to substitute a valid, legal,
6 and enforceable provision that implements the purposes and intents of this Agreement.

7 11.3 No Third Part Beneficiaries. This Agreement is made and entered into for
8 the sole protection and benefit for the parties hereto. No other person or entity shall
9 have any right of action based upon the provisions of this Agreement.

10 11.4 Notices. All notices, requests, demands, waivers, consents, and other
11 communications hereunder shall be in writing and shall be either , hand-delivered, sent
12 by certified mail, or delivered by a regionally or nationally recognized overnight courier
13 service, freight prepaid, and shall be deemed to have been duly given and to have
14 become effective upon receipt, directed to the parties at the following addresses (or at
15 such other address as shall be given in writing by a party hereto):

1 11.5 Entire Agreement. This Agreement and those documents incorporated
2 herein by reference or attached: (i) constitutes the entire Agreement, supersedes all
3 other prior Agreements and understandings, both written and oral, among the parties,
4 or any of them, with respect to the subject matter of this Agreement; (ii) is not intended
5 to confer upon any person other than the parties to this Agreement any rights or
6 remedies under this Agreement.

7 11.6 Additional Documents. In addition to the documents and instruments to
8 be delivered as provided in this Agreement, each of the parties shall, from time to time
9 at the request of the other party, execute and deliver to the other party such other
10 documents and shall take such other actions as may be reasonably required to carry
11 out the terms of this Agreement.

12 11.7 Jurisdiction and Venue. This Agreement shall be governed and
13 construed in accordance with the laws of the State of California. The Successor
14 Agency and FSA agree that the Agreement has been entered into at Riverside County,
15 California, and that any action or proceeding commenced to enforce or interpret this
16 Agreement shall be filed in the Superior Court for the State of California, in Riverside,
17 California.

18 11.8 Attorney's Fees. In the event of any litigation between the Successor
19 Agency and FSA to enforce any of the provisions of this Agreement or any right of
20 either party hereto, the unsuccessful party to such litigation shall pay to the prevailing
21 party all costs and expenses, including reasonable attorney's fees, incurred therein by
22 the prevailing party, all of which shall be included in and as part of the judgment
23 rendered in such litigation. 11.9 Relationship to the Successor Agency and FSA.

24 Nothing contained herein shall be deemed or construed as creating the relationship of
25 principal and agent or of partnership or of joint venture by the parties hereto, it being
26 understood and agreed that no provision contained in this Agreement nor any acts of
27 the parties hereto shall be deemed to create any relationship other than the
28 relationship of lessor and lessee. FSA is an independent contractor.

11.9 Binding on Successors. The terms, covenants, and Agreements herein contained shall bind and inure to the benefit of the Successor Agency, FSA, and each of their successors and permitted assigns.

11.10 Amendment. This Agreement shall not be modified or amended without the mutual consent of both FSA and the Successor Agency incorporated in a written amendment to the Agreement.

11.11 Counterparts. This Agreement may be signed by different parties in counterparts, each of which shall be an original but all of which together shall constitute one and only and the same Agreement.

11.12 Waiver. Failure by a party to insist upon the strict performance of any of the provisions of this Agreement by the other party, or the failure by a party to exercise its rights upon the default of the other party, shall not constitute a waiver of such party's rights to insist and demand strict compliance by the other party with the terms of this Agreement thereafter.

11.13 Authority to Execute. The persons executing this Agreement or exhibits attached hereto on behalf of the parties to this Agreement hereby warrant and represent that they have the authority to bind the respective parties to this Agreement to the performance of its obligations herein.



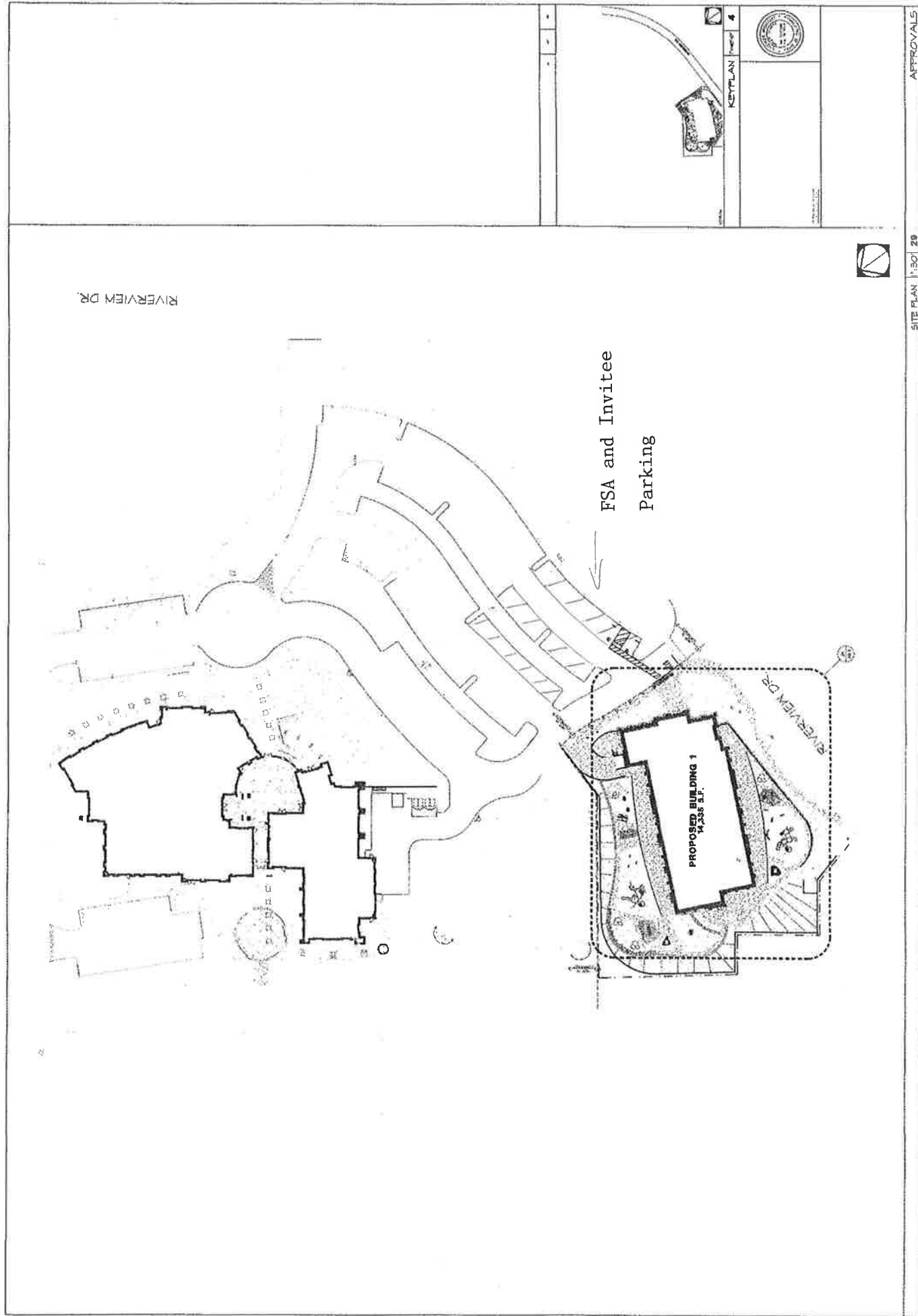
