BACKGROUND: Government Code § 25845, Riverside County Ordinance Nos. 457, 541 and 725 authorize the recovery of abatement costs in public nuisance cases, the recordation of a notice of abatement lien and inclusion of abatement costs on the tax roll as a special assessment upon approval of the Board of Supervisors.

Notices of Violation were issued. On or about January 14, 2010 Case Nos. CV08-04489, CV08-04490 & CV08-04491 were closed with the violations remaining. Case number CV10-00334 is currently open to address the remaining violations. The Board of Supervisors issued an Order to Abate Nuisance in this case on April 6, 2010. On or about August 10, 2010, the substandard mobile homes located on the subject property were abated under the direction of the Riverside County Code Enforcement Department pursuant to seizure warrant MISC2010-075. The Code Enforcement department was unable to complete the necessary abatement of the remaining violations, accumulated rubbish and substandard structures, due to budgetary constraints. Riverside County Code Enforcement seeks to recover its fees and costs to date and does not waive its right to recover future costs associated with the handling of this matter.

The Notice of Hearing re Statement of Abatement Costs has been posted on the property and mailed to the property owner and all interested parties, as required by law. Copies of all relevant notices issued in this matter together with proof of service and posting have been separately filed with the Clerk of the Board and are made a part of the record herein, pursuant to Riverside County Ordinance 725.
