CONSULTING SERVICES AGREEMENT MORENO MASTER DRAINAGE PLAN UPDATE

PROJECT NO. 4-0-00828 Environmental Services

The RIVERSIDE COUNTY FLOOD CONTROL AND WATER CONSERVATION DISTRICT, hereinafter referred to as DISTRICT, and ALBERT A. WEBB ASSOCIATES, hereinafter referred to as CONSULTANT, previously entered into that certain Agreement, hereinafter referred to as AGREEMENT, dated June 7, 2011 to perform environmental services in support of DISTRICT'S Moreno Master Drainage Plan Update project, hereinafter referred to as PROJECT; and

WHEREAS, the Time for Performance of AGREEMENT expired on June 30, 2012; and

WHEREAS, DISTRICT wishes CONSULTANT to complete the first tier, Environmental Impact Report (EIR) of PROJECT and CONSULTANT is willing to continue the performance of such services as provided herein.

NOW, THEREFORE, DISTRICT and CONSULTANT mutually agree to amend the AGREEMENT as follows:

1. Section 3 is amended to read:

3. <u>TIME FOR PERFORMANCE</u>

CONSULTANT agrees that it will diligently and responsibly pursue the performance of work and services in accordance with the Project Schedule attached hereto as Attachment "B" and made a part hereof.

CONSULTANT shall not commence performance of any work or services, for any reason whatsoever, until DISTRICT has provided

CONSULTANT with a written Notice to Proceed authorizing CONSULTANT to initiate work pursuant to this Agreement. The term of this Agreement shall start on the date the Agreement is executed by DISTRICT'S Board of Supervisors, and end on June 30, 2013 with an option for one (1) additional one-year extension. Prior to the termination date of this Agreement, this Agreement may be extended for an additional fiscal year by mutual written consent of DISTRICT and CONSULTANT. No payment will be made for any work or services performed prior to issuance of said Notice to Proceed.

2. A new Section 23 is added to read:

23. DISCREPANCIES

In the event of any conflict between the terms of this Agreement and Attachment "A", Attachment "B" or Attachment "C", the terms of this Agreement shall govern. In the event of any conflict between Attachment "A" and Attachment "B" or Attachment "C", the following precedence shall apply: Attachment "A"; Attachment "C"; Attachment "B".

3. Except to the extent specifically added to, modified or amended herein, all of the terms, covenants and conditions of said AGREEMENT dated June 7, 2011, shall remain in full force and effect between the parties hereto.
