**BACKGROUND:** Community Improvement Designation funds will be given to support: Riverside County Foundation on Aging's Holiday Gift Program which will benefit seniors in the 1<sup>st</sup> District, Riverside Dickens' 2013 Festival to support Riverside's only literary festival, to assist the City of Riverside-PRCSD with funds to bring a music school to Bobby Bonds, to assist J.W North High School with payment of a facility use permit to utilize the soccer field at Bobby Bonds (Riverside-PRCSD), Boy Scouts of America to benefit the Mt. Rubidoux Boy Scout program, services and programs at March Field Museum, Riverside National Cemetery as they recognize local veterans at the Memorial Honor Detail, Path of Life Ministry's mission to serve the homeless people in the 1<sup>st</sup> District, and finally funds will be provided to Martin Luther King High School's 2013 King High Remembers which honors local veterans.
