The Riverside County Economic Development Agency (EDA) hereby notifies concerned members of the public, pursuant to 24 CFR 91.105(e), that the County of Riverside Board of Supervisors will hold a public hearing to obtain the views and comments of residents, service providers, local governments, and other interested parties regarding:

1. the performance of the County's 2011-2012 HUD/CPD-funded programs (Community Development Block Grant (CDBG), Home Investment Partnership Act (HOME), and the Emergency Shelter/Emergency Solutions Grant (ESG));

The public hearing will be held at 11:00 AM on December 4, 2012, in the Board of Supervisors' Chambers, County Administrative Center, 4080 Lemon Street, 1st floor, Riverside, CA. The public may present oral or written comments during the public hearing.
