BACKGROUND: Community Improvement Designation funds will be given to local community organizations dedicated to serving the public. The Pedley Volunteer Fire Department needs to replace their aging squad vehicle in order to comply with the department standard for this particular piece of equipment. Using the specifications provided by the Pedley Volunteer Fire Department, this donation will enable the Riverside County Purchasing Director to procure said squad vehicle.
