#### FIRST AMENDMENT

#### TO THE

## PROFESSIONAL MEDICAL SERVICES BETWEEN

### COUNTY OF RIVERSIDE

UNIVERSITY SCHOOL OF MEDICINE

## AND FACULTY PHYSICIANS AND SURGEONS OF LOMA LINDA

That certain Agreement between the County of Riverside (COUNTY) on behalf of the Riverside County Regional Medical Center (HOSPITAL) and Faculty Physicians and Surgeons of Loma Linda University School of Medicine (CONTRACTOR) effective November 1, 2008 is hereby amended effective February 1, 2013, pursuant to the following:

- 1. Delete Exhibit A, Section 1.0 in its entirety and replace as follows:
- "1.0 Subject to the conditions set forth below, HOSPITAL shall pay CONTRACTOR one hundred sixty two thousand, eight hundred (\$162,800) dollars for the services of one (1) .50 professional to provide administrative services and oversight for the HOSPITAL Child Abuse and Neglect (CAN) clinic, peer review of all child abuse medical examinations, develop medical protocols for evaluation of suspected child abuse and neglect, and to provide administrative, supervisory, teaching services and to direct patient care. In addition to the above, HOSPITAL shall pay CONTRACTOR an additional fifty-one thousand, two hundred (\$51,200) dollars per year for on-call coverage and telephone consultation to the HOSPITAL Emergency Room, Child Protective Services, law enforcement, SANE's or County District Attorney's office. CONTRACTOR agrees to assist appropriate COUNTY authorities in the development of forensic guidelines for evidence collection and preservation, case review protocols, and protective services. The total payment includes an incentive for meeting performance requirements listed in Section 1.2 below. Payments to CONTRACTOR shall be

	made on a monthly basis during the Term of the Agreement. HOSPITAL shall pay
