## **BACKGROUND:**

The Internal Revenue Service estimates that 25% of California's eligible EITC funds go unclaimed each year. EITC is recognized nationally as one of the most effective means to move low-income people out of poverty. Since 2004, CAP Riverside has coordinated Volunteer Income Tax Assistance (VITA) sites. Over 14,158 income tax returns have been completed, generating over \$19.5 million in tax refunds for low-income residents of Riverside County.

Again, this coming tax season, United Way and Bank of America are partnering with CAP Riverside by providing \$10,000 to expand the EITC outreach efforts within Riverside County. The funding will be utilized to cover the cost of advertising and marketing materials.

FINANCIAL IMPACT: No County General Funds will be required.

# 2013 MEMORANDUM OF UNDERSTANDING BETWEEN UNITED WAY OF THE INLAND VALLEYS AND COMMUNITY ACTION PARTNERSHIP OF RIVERSIDE COUNTY

- Preamble: Community Action Partnership of Riverside County (CAP Riverside) recognizes that it has entered into a partnership with United Way of the Inland Valleys per its acceptance of a grant from Bank of America in the amount of \$10,000 for the purpose of building the capacity of Earned Income Tax Credit (EITC) outreach and free tax preparation efforts in Riverside County.
- II. Community Action Partnership of Riverside County Commits to:
  - A. Utilize the funding provided to broaden EITC outreach and free tax preparation efforts within Riverside County.
  - B. Outline the specific use(s) of the grant funds in Section III (Scope of Work) of this Memorandum of Understanding.
  - C. Track the following data:
    - Number of volunteers
    - Number of Bank of America volunteers
    - Number of volunteer hours
    - Total number of returns filed
    - Total amount of refunds to clients who used VITA services
    - Total amount of EITC returned to clients of VITA services including all tax credits
  - D. Collect and submit demographic data, including:
    - Gender
    - Race/ethnicity
    - Education level
    - Housing status
    - Banking relationship
    - Planned use of refund
    - How taxes were filed last year
  - E. Submit a final report to United Way of Inland Valleys summarizing the activities during the tax season, the activities supported by the grant, and the results of the EITC outreach program (represented by the indicators listed above). The report must be submitted no later than June 28, 2013.
  - F. List United Way of the Inland Valleys and Bank of America as sponsors, where possible, on the campaign's website and on its marketing and other campaign materials.

Ill. Scope of Work: CAP Riverside will use the funds provided by Bank of America to broaden EITC outreach and free tax preparation. The \$10,000.00 in funding will be used in outreach; estimated total circulation is 373,236 households. The advertising will be in key local newspaper ads throughout Riverside County in English and in Spanish. 22,000 printed materials will be distributed at key locations in various communities such as parks and recreation sites, libraries, schools, social service agencies and church sites.

Part of the outreach/marketing plan will focus on making information available to local employers so they may provide this information to their employees who would be eligible to access the tax sites or who may be interested in volunteering.

CAP Riverside volunteer recruitment efforts will also target Bank of America employees in United Way of the Inland Valleys service region. In addition, CAP Riverside will host a media event on Friday, January 27 2012 for National EITC Awareness Day with elected officials, media, United Way staff and CAP staff. The event will be held at the Southwest Veterans' Business Resource Center located in Perris, California, and will showcase the CAP Riverside Mobile Unit for free on-site tax preparation.

### PROPOSED SITES:

CAP Riverside will open 12 VITA sites throughout Riverside County, including the following: Arlanza Public Library, Blythe Community Center, Casa Blanca Library, Center for Employment Training (CET) Desert Hot Springs Family Resource Center, Glen Avon Library, Mount San Jacinto College, Riverside Community College, Southwest Veteran's Business Center, Moreno Valley Youth Opportunity Center, and the Lake Elsinore Senior Center.
