#### RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF RIVERSIDE ESTABLISHING MILEAGE OF MAINTAINED COUNTY ROADS PURSUANT TO SECTION 2121 OF STREET AND HIGHWAYS CODE

WHEREAS. Section 2121 of the Street and Highways Code provides that each County annually shall submit to the California State Department of Transportation any additions to; or exclusions from; its mileage of each route added or excluded; and,

WHEREAS, the California State Department of Transportation certified in May 2012 to the California State Controller that the total mileage of County maintained roads in Riverside County was 2,186.93 miles; and,

WHEREAS, the County now finds that the total mileage of County maintained roads is 2,184.15;
