BACKGROUND:

When the existing County General Plan was developed and ultimately adopted in 2003, the development process included a General Plan Advisory Committee (GPAC). This committee was comprised of 23 members whose purpose was to provide input to consultants and staff. Since the scope of the current General Plan update (GPA No. 960) proposed fewer

modifications than its predecessor, the Board reduced the membership of the GPAC committee in April 2008. The new GPAC met monthly for most of 2008 and 2009 and then went into hiatus pending the receipt of several draft deliverables from the County. These deliverables included the draft Circulation Element, the draft Air Quality Element and the draft Climate Action Plan.

At this time, the aforementioned deliverables are now ready for GPAC review. Due to a long hiatus and departure of several GPAC members, it is important to reconfirm the GPAC membership at this juncture. As proposed in Attachment A, the advisory committee is comprised of 15 members. The committee is expected to work closely with staff as an integral part of the General Plan development team. Due to the limited number of remaining General Plan items and the County's goal of releasing the draft document for public review in early fall, GPAC will conduct two meetings in June and July of this year.

It is anticipated that the cost to support final GPAC review will not exceed \$5,000. Funding for this effort will come from Net County Cost already set aside for GPA No. 960 and EIR No. 521 in FY 12/13 and FY 13/14. The sunset date for this committee is September 30, 2013. The anticipated schedule for GPA No. 960 and EIR No. 521 is included as Attachment B.
