SUBJECT: Approve the amendments to agreements with Catholic Charities of San Bernardino Riverside and MFI Recovery Center, Inc.

RECOMMENDED MOTION: That the Board of Supervisors:

1. Approve and authorize the Chair of the Board to sign the attached amendments to the agreements with Catholic Charities of San Bernardino Riverside (CS-02390-03) and MFI Recovery Center, Inc. (CS-02399-03), with the option to renew for four additional one-year periods, with an aggregate amount not to exceed \$1,351,678.40
2. Authorize the Director of the Department of Public Social Services (DPSS) to administer the contract.
3. Authorize the Purchasing Agent, in accordance with Ordinance No. 459, to exercise the renewal options, based on the availability of fiscal funding, and to sign amendments that do not change the substantive terms of the agreement, including amendments to the compensation provision that do not exceed the annual CPI rates.

BACKGROUND (Continued):

On June 12, 2012 (Agenda #3.15), the Board of Supervisors approved the agreements with Catholic Charities of San Bernardino/Riverside and MFI Recovery Center, Inc. to provide Core Services (Anger Management, Counseling, Domestic Violence, In-Home Parenting, Parenting Education and Substance Abuse).

On February 26, 2013 (Agenda #3.48), the Board of Supervisors approved Amendment #1 to the agreements with Catholic Charities of San Bernardino/Riverside and MFI Recovery Center, Inc. increasing their Maximum Reimbursable Amount's by \$66,650.00 and \$33,349.08, respectively, in order to address increased service demands. Since that amendment, both agencies have continued to experience greater service demands, and as a result, we are recommending another amendment to the agreements with Catholic Charities of San Bernardino Riverside and MFI Recovery Center, Inc.

DPSS has identified savings through other contracts to apply towards these amendments. However, even with these shifts, none of the agencies that are contributing savings will have less than the original base funding allocated. As a result, we are able to meet the increased needs in specific areas and ensure that service levels are also sustained in all areas of the county. We have allocated the savings to the Catholic Charities and MFI contracts as follows:

Catholic Charities

- \$31,558 in PSSF funding from the JFK Safecare contract
- \$9,100.20 in PSSF funding from a cancelled contract with Parent's Anonymous

MFI Recovery Center, Inc.

- \$1,442 in PSSF funding from the JFK Safecare contract
- \$15,000 in CBCAP funding from the JFK Safecare contract
- \$14,000 from the FSA Safecare contract
- \$62,823.43 from CWSOIP funding – additional funding not previously allocated.

FINANCIAL:

Funding for these contracts is 100% State and Federal funds and was budgeted through the normal County budget process.
