BACKGROUND: The East Hemet Resurfacing Project will provide road improvements to five neighborhoods in the East Hemet area -- four in the community of East Hemet and one in the community of Valle Vista. The roads were selected for the improvements based on pavement conditions associated with the age of the roads. A slurry seal treatment cannot improve the condition of the roads and the pavement needs to be replaced.

The existing pavement will be removed by pulverizing or coldplane and new pavement will be placed. In addition to the new pavement, curbs, and gutters that are in poor condition will be replaced and driveway approaches impacted by the project will be replaced. Any existing access ramps that do not meet the current Americans with Disabilities Act (ADA) requirements will be improved or replaced to meet the new requirements. Several new access ramps will also be added. New thermoplastic pavement markings, painted traffic stripes, and reflective pavement markers will be provided.

The roads included in this project are listed on Attachment 1.

The bid documents include the following schedules of work:

Base Bid: Primary items of work

Alternate 1: Adjustment of sewer manholes to grade to be funded by the Lake Hemet Municipal Water District

If the Lake Hemet Municipal Water District (LHMWD) concurs with bid prices, as bid by the apparent low bidder, the alternate bid schedule will be included with the contract award, and the costs for the work will be funded by LHMWD.

The submitted plans and specifications have been approved as to form by County Counsel.

Environmental clearance is complete.
