

BACKGROUND: The Transportation Improvement Program (TIP) provides for the construction of a traffic signal, lighting, and intersection improvements at Grand Avenue and Blackwell Boulevard within the community of Lakeland Village. This intersection met the warrants for traffic signal control. The proposed traffic signal will improve traffic operations and safety. Other improvements consist of constructing sidewalk, curb and gutter, curb ramps to comply with Americans with Disabilities Act (ADA) requirements, roadside signs, installing painted traffic stripes and thermoplastic pavement markings, and associated improvements.

Annual traffic signal operation and maintenance costs are estimated at \$5,500 to be funded from gas tax.

The Development Impact Fee (DIF) program, which is governed under Ordinance 659.6, allows for the use of DIF funds for traffic signal facilities.

The bid documents include the following schedules of work:

Base Bid: Primary items of work

Alternate 1: Construction of 8-inch and 4-inch waterline, which will be funded by the Elsinore Valley Municipal Water District (EVMWD)

If EVMWD concurs with bid prices, as bid by the apparent low bidder, the alternate bid schedule will be included with the contract award, and the costs for the work will be funded by EVMWD in accordance with the funding agreement executed by the Board of Supervisors on April 9, 2013 (Agenda Item 3-32).

The submitted plans and specifications have been approved as to form by County Counsel.

Environmental clearance is complete.

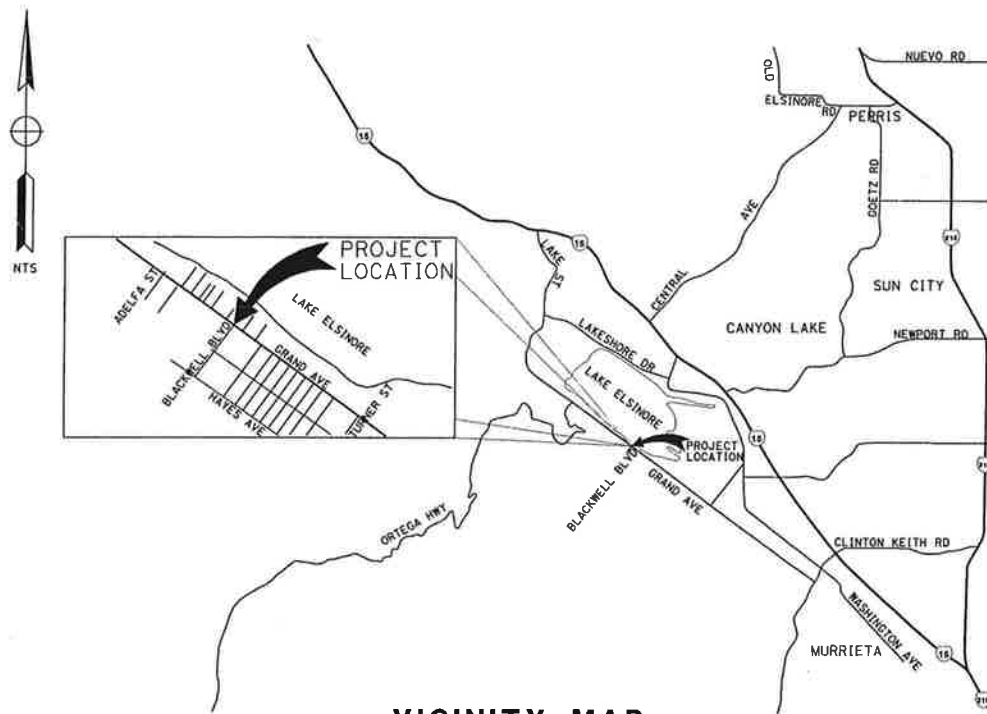
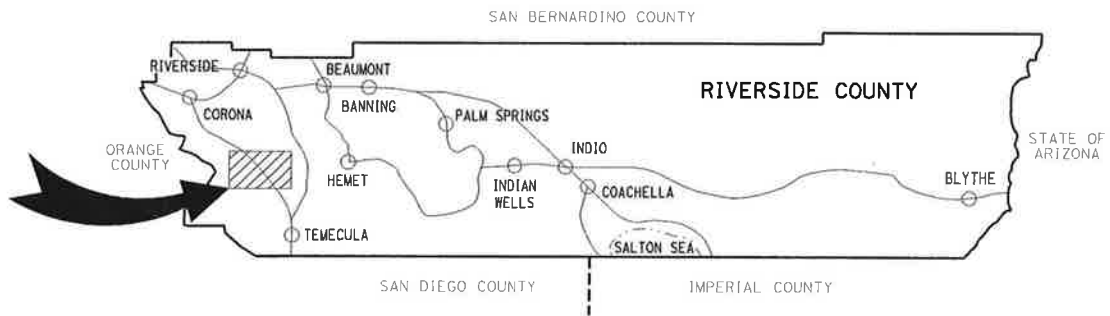
