BACKGROUND:

On October 25, 2012, the County entered into a contract with Vance Corporation for the construction of the Taxiway A Rehabilitation Project for the Jacqueline Cochran Regional Airport. The project consisted of rehabilitating and refurbishing the taxiway, serving the Signature Fixed Base Operator (FBO) Leasehold, the John and Betty Obradovich FBO Leasehold, the CHP Air Operation Leasehold and the general public. The project was completed on May 1, 2013, and the airport has been returned to its full operational capacity.
