BACKGROUND: The County Transportation Improvement Program (TIP) provides for improvements to Murrieta Hot Springs Road, Winchester Road to Calistoga Avenue, east of the city of Murrieta.

By Minute Order dated June 4, 2013 (Agenda Item 3-50), the Board of Supervisors approved the plans and specifications and authorized the Clerk of the Board to advertise for the construction of the Murrieta Hot Springs Road Resurfacing Project.

During the advertisement period, one addendum was issued to all registered plan holders as a supplement to the plans, specifications, and special provisions. Bidders are required to acknowledge and take into account all issued addenda on their Contractor's Proposal in order to be considered for award. The addendum was issued to clarify and modify the approved contract documents. The addendum is attached as Addendum No. 1.

Bids for the project were opened in the office of the Director of Transportation and Land Management at 2:00 p.m., Wednesday, June 26, 2013. Four bids were received, ranging from \$1,494,000 to \$1,526,649. The basis for the selection of a contractor is the lowest responsive and responsible bid. The lowest responsible bid was submitted by Hardy & Harper, Inc. in the amount of \$1,494,000. The proposal included one base bid and three alternate bid schedules. Alternate Bid Schedule 1 (Median Improvements) and Alternate Bid Schedule 2 (Utility Adjustments—Eastern Municipal Water District [EMWD]) are not selected for award. The Median Improvements will be done by Special Assessment Districts L&LMD and Community Services Area (CSA); and, EMWD will do utility adjustment work with their own forces as needed. The Transportation Department recommends award of the Base Bid and Alternate No. 3 schedules of work. Therefore, the total agreement amount is \$1,305,000, which is \$2,900 (0.2%) below the Engineer's Estimate.

The existing pavement on Murrieta Hot Springs Road is in poor condition and requires resurfacing. The project will remove and replace the existing AC pavement on Murrieta Hot Spring Road. Access ramps will be improved to meet the current Americans with Disabilities Act (ADA) standards. New striping, pavement markings, and reflective markers will be installed. The project includes sidewalk replacement due to lifted and cracked sidewalk on Sky Canyon Drive. De Luz Road shoulder widening work was added by addendum and is included in Alternate Bid Schedule 3.

The work is scheduled to begin in late summer of 2013. The work will be phased to keep the road open during construction and will take approximately three months to complete.

The contractor is qualified to perform the work as outlined in the bid and has executed the contract and provided bonds and insurance documents, which meet the requirements of the contract.

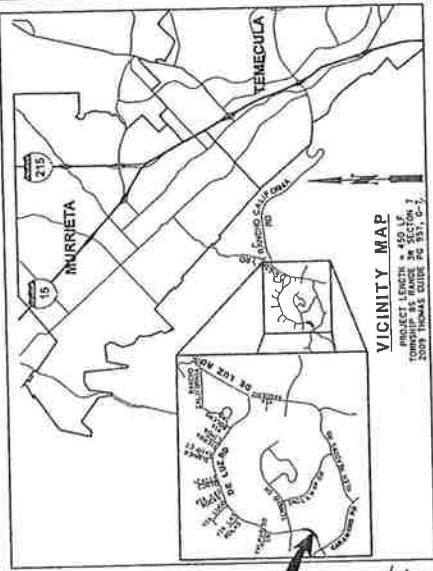
