Summary

California Elections Code §§ 10002, 10402, and 10403 allow jurisdictions to request that the Board of Supervisors approve the Registrar of Voters to conduct and consolidate elections by submitting a resolution requesting these services. The jurisdictions listed on Exhibit A have complied with this requirement and have requested the Registrar of Voters to conduct and consolidate their elections. The department has the resources to conduct and consolidate these elections. The jurisdictions will reimburse the department based on associated direct costs.
