BACKGROUND:

Summary

Avenida Florencita provides a significant pedestrian link between Bubbling Wells Elementary School and the westerly residential area. Avenida Florencita currently contains obstructions to pedestrians use, such as fences, trees, signs, and parked vehicles. This project proposes to construct approximately 2,500 linear feet of sidewalk on the east side of Avenida Florencita to provide a safer pedestrian path.

The submitted plans and specifications have been approved as to form by County Counsel, and environmental clearance is complete.

Impact on Citizens and Businesses

The proposed improvements will improve pedestrian safety and provide an Americans with Disabilities Act (ADA) compliant path.

Additional Fiscal Information

The construction contract is estimated to cost approximately \$168,000, and construction is expected to finish in FY 2013/2014 and will be funded with Measure A/Coachella Valley funds and with SB-821 funds, for which the County successfully completed.

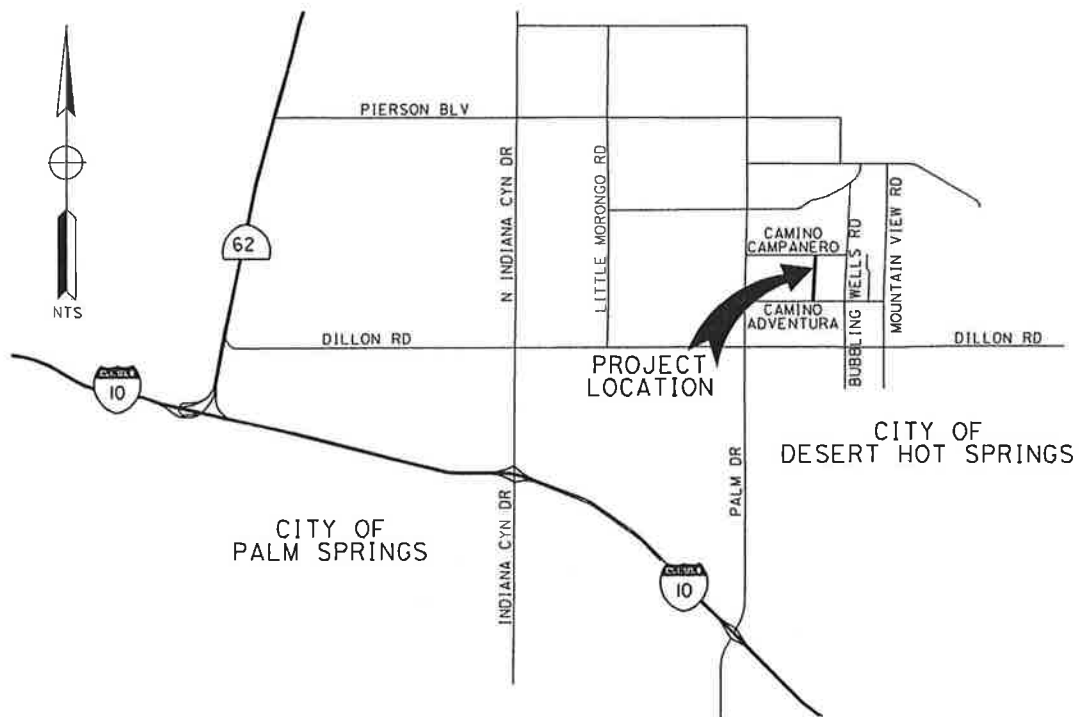
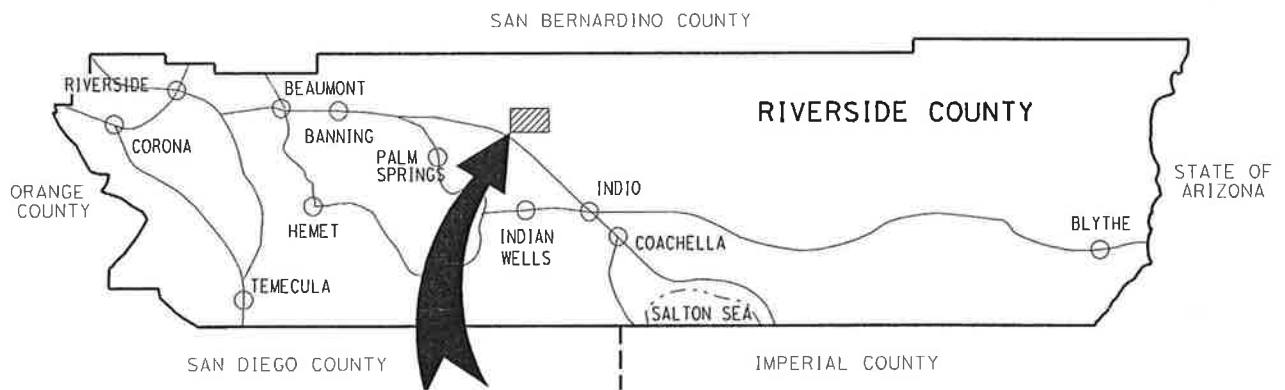
