BACKGROUND:

Summary

The California Emergency Management Agency (Cal EMA) approved Riverside County's Homeland Security Grant Program application in the amount of \$1,000,000 and has authorized spending and reimbursement of Anti-Terrorism Approval Authority of this approved amount. This project will increase the effectiveness of perimeter security at the sheriff's central dispatch center. On July 17, 2012, the Board of Supervisors approved the perimeter fencing upgrade project (M.O. 3.13).

On October 16, 2012, the Board of Supervisors approved the construction agreement for Job Order Contract No. 005 between the County of Riverside and De La Riva Construction, Inc. Pursuant to the contract, various job orders were issued for the Sheriff's Department in support of the Sheriff 911 K12 Gates project in the combined amount of \$529,323.

The project has been inspected and found to comply with all contract requirements. This Board action will release the contract retention funds of \$26,466 to De La Riva Construction, Inc. The contract retention funds are within the overall project budget and no additional funding is required.

All costs associated with the project will be fully funded by the U.S. Department of Homeland Security/FEMA Grant, thus no net county costs will be incurred.

Impact on Residents and Businesses

The purpose of this project is to establish effective facility perimeter security to include secured parking for staff at the Sheriff's Central Dispatch Center. The project includes reinforced security fencing, lighting and security cameras. The dispatch center serves 17 contract cities and all unincorporated areas of California's fourth largest county. As the communications hub supporting all allied agencies and private sector partners, the center serves a population of over two million people for emergency services.

This facility is a key resource/critical infrastructure for public and law enforcement communications and the intake of 911 emergency calls for Riverside. The Communications Center operates 24/7 with a large number of personnel and houses critical radio/communication technology and repair equipment.

Recording the Notice of Completion for De La Riva Construction, Inc., will not impact residents and businesses.
