# **RECOMMENDED MOTION:** That the Board of Supervisors:

- 1. Approve and authorize the Chairman to execute the attached amendment to the Contract Agreement with General Security Services, Inc. for an additional four months, effective March 1, 2014, adding an additional \$221,456 to the contract maximum amount through June 30, 2014; and
- 2. Authorize the Purchasing Agent, in accordance with Ordinance No. 459, to sign amendments that do not change the substantive terms of the agreement, and to allow the Purchasing Agent to increase the compensation amount not more than ten percent of the annual amount.

other is located at the Inpatient Treatment Facility (ITF) in the city of Riverside, CA. The security guard service for both facilities is required to ensure a safe, calm, secure, peaceful environment for employees and patients. Buildings and contents should be protected against theft, pilferage and vandalism. More specifically at the ITF campus, security personnel present a level of visible deterrent to prevent clients from becoming violent belligerent and unruly. These unarmed security guard services are provided with a minimum of three security guard officers, twenty-four (24) hours a day, seven (7) days per week, and three hundred sixty-five days a year.

#### Impact on Citizens and Businesses

This service has a positive impact to patients, visitors and surrounding businesses in Riverside County by providing a safer and peaceful environment at the facilities.

# Contract History and Price Reasonableness

Formerly, each facility conducted separate Request for Proposals (RFPs) and maintained its own separate contracts agreements. General Security Services, Inc. was the awarded vendor for each facility. On April 23, 2013, agenda item #3-51, the Board approved to combine both contracts for a combined aggregate amount of \$770,500 annually. Combining the contracts has resulted in more efficient contract administration.

General Security's current contract agreement ends February 28, 2014, with no additional renewal options remaining. This four month extension amendment is to secure continuity of services at both campuses through June 30, 2014 and until the RFP for a new contract is complete. The contract rate will remain the same as awarded through the previous RFP RCRMC conducted previously in Mach 2010.

#### FOURTH AMENDMENT TO THE PROFESSIONAL SERVICES AGREEMENT

#### **WITH**

# GENERAL SECURITY SERVICES, INC.

(Unarmed Security Guard Service)

That certain Agreement between County of Riverside ("COUNTY") and General Security Services, Inc., ("CONTRACTOR"), initially approved by the Board March 2, 2010, Agenda Item #3.18, first amendment executed March 2, 2011, second amendment executed May 11, 2012, and third amendment executed April 23, 2013, Agenda Item #3-51, is hereby amended as follows:

1. Amend the language of Section 3.0 Period of Performance, to include the following:

"This Amendment extends the period of the Agreement effective March 1, 2014 through June 30, 2014, unless terminated as otherwise provided herein."

2. Amend the language of Section 4.0 Compensation, subsection 4.1, to state as follows:

"Maximum payment by COUNTY to CONTRACTOR shall not exceed nine hundred ninety-one thousand nine hundred fifty six dollars (\$991,956) through June 30, 2014. The COUNTY is not responsible for any fees or costs incurred above or beyond the contracted amount and shall have no obligation to purchase any specified amount of services."

3. All other terms and conditions of this Agreement are to remain unchanged.
